### IV. Follow-Up Comments, Questions, Rebuttals

In response to concerns expressed about the potential impact of the proposal on other licensed mental health professionals Dr. Mark Schriever, PsyD, stated that the proposal would not require other, licensed mental health professionals to acquire a license as an ABA in order to provide ABA services. Dr. Gina Green, PhD, BCBA-D, commented that ABA is a profession not a modality. Sarah Voss, LMHP, commented that the ABA proposal would set the standards of care for mental health services for ABA services in Nebraska. Georgia Ryba commented that ABAs are trained in a team approach to care, and that they highly value working with other mental health professionals to provide these services.
