2. Overview of the Year One Evaluation Report

- Written and submitted to DHHS by contractor, Technical Assistance Collaborative (TAC);
- Summarizes progress of strategies and outcomes by each goal for plan year One, July 1, 2020-June 30, 2021 (evaluation of the first 6 months of plan implementation);
- Highlights achievements, challenges, and recommendations for each of the seven goals;
- Reviewed achievements identified in the report;
- Report available upon request;
- DHHS determined the need to establish three workgroups to address further implementation of the plan strategies;
- Overall goals of the workgroups is to ensure the completion of strategies identified for year one of the plan or identify revisions to current strategies, and to ensure the plan is moving Nebraska forward in meeting the overall vision of the Olmstead plan in each of the seven goals.

Powerpoint presentation was shared again with closed captioning capabilities continuing.

3. Discussion on Olmstead Workgroups

- a. Education and Employment
 - Focus areas: Special education, post high school transitions, and increased access to integrated employment;
 - Emcompasses strategies identified in goals number four and seven;
 - One workgroup meeting held March 2, 2021;
 - Will meet the first Tuesday of every month at 9:00 am.
 - Next meeting will identify priorities of the workgroup for the next three months.

b. Housing

- Focus areas: Community-based and accessible housing;
- Emcompasses strategies identified in goals number one, two, and three;
- Strategy 2.4 is being met by a cross-divisional workgroup facilitated by the Division of Behavioral Health;

- Olmstead Housing workgroup will work collaboratively with the cross-divisional workgroup and focus on supportive services, reducing homelessness in youth ages 18-24, barrier removal, and non-production strategies;
- Kick-off meeting tentatively scheduled for March 24, 2021, at 3:00 pm.

c. Data

- Focus areas: Data collection and sharing;
- Emcompasses strategies identified in goals number three and six;
- First meeting was with DHHS representatives as goal six has several strategies around DHHS collecting, aggregating, and evaluating data across DHHS;
- Next meeting is April 7, 2021, at 11:00 a.m.;
- Future meetings will include representatives from the other state agencies on the Steering Group.

4. Discuss Identification and Engagement of Persons with Disabilities for each workgroup

- Seeking volunteers from people with disabilities and representatives from advocacy organizations for each of the workgroups;

- Application is being developed and will be posted to the website and sent to advocacy organizations asking to send out to listservs;

5. Public Comments

• Discussion on urgent need of people with disabilities with underlying health conditions to be vaccinated; DHHS is working hard to make sure the vaccine is available to priority populations outlined in the vaccination plan. Home and Community Based Waiver participants and staff (approx. 10,000 participants) were prioritized in Phase 1A. Current vaccination plan focuses on CDC recommendations by age group. Additionally 10% in Phase 2A is being set aside for people with high risk medical conditions. Discussion included involving individuals from the local health departments in the Olmstead effort if there isn't an already established relationship with the disability community, advocates, and local health departments.
