Title 175 NAC Chapter 14: Regulations Governing Licensure of Home Health Agencies

O: Will Nebraska DHHS, Licensure Unit revise Title 175 NAC 14 to allow a Nebraska-licensed nurse practitioner or a Nebraska-licensed physician assistant to write HHA orders and sign the HHA patient's plan of care after the COVID-19 public health emergency has ended?

A: To implement, as allowed by Nebraska law, a recent Medicare HHA survey and certification change, the Licensure Unit intends to revise Title 175 NAC 14 to allow a Nebraska-licensed nurse practitioner or a Nebraska-licensed physician assistant to write HHA orders and sign the HHA patient's plan of care. To comply with the Respiratory Care Practice Act requirements, these proposed revisions would not apply to 175 NAC 14-006.03 requirements for Medical Director when the agency is providing respiratory care by a respiratory care practitioner. Until these proposed revisions to Title 175 NAC 14 are approved or denied, the Licensure Unit will not cite a deficiency nor take a licensure action against a HHA for non-compliance with the requirement that only a physician may order and/or approve the HHA patient's plan of care as specified in 175 NAC 14.

Q: How will I know when the above proposed revisions to Title 175 NAC 14 receive <u>final</u> approval or denial?

A: The regulatory process for revising Title 175 NAC chapters has multiple review steps before Nebraska DHHS is notified of <u>final</u> approval or denial.

Once a finalized <u>draft</u> of the Licensure Unit's proposed revisions to 175 NAC 14 is approved for public hearing, the draft and public hearing information can be viewed on the Nebraska Secretary of State public website at:
