**MEETING MINUTES  
March 8, 2024**

Amy mentioned the cyber attack on a clearinghouse “Change Healthcare” that processes claims and approves verification for patient coverage, etc. This has impacted many clinics and hospitals financially.

Medicare Advantage Plans are also impacting clinics and hospitals detrimentally due to their low percentage of payment on claims. Amy will be meeting with Congressman in Washington, D.C. regarding payor reform.

NMA has also been in conversations with the Athletic Trainers Association regarding expanding their scope of practice to include some Surgical First Assistant scope of practice procedures. The conversations include exploring a 407 application to expand their scope of practice.

##### Surgical First Assistant Application(s) (1)

Basis for the denial: The Board recognizes and acknowledges the importance of both athletic trainers and surgical first assistants. However, in this case without a credential issued by another state or territory the Board does not have authority to waive the education and examination requirements of 38-3512. Voting aye: Blake, Hedrick, Keagan, Kuenning, Massey and Zeger. Voting nay: None. Absent: Goodman and Howorth. Abstain: None. Motion carried.

#### **PHARMACEUTICAL CARE AGREEMENT(S)**

#### **PHYSICIAN ASSISTANT COLLABORATIVE AGREEMENT DISCUSSION**

The Board agreed that they would like to review the Collaborative Agreement between a PA and the Supervising Physician in all future investigation case files.

#### **THE BOARD OF MEDICAL RADIOGRAPHY'S OPINION ON BODY COMPOSITION EXAMS IN DEXA**

The Board agrees that it is not within the Medical Radiographer's scope of practice to answer questions regarding the results of a procedure or x-ray. The Physician that ordered the procedure or x-ray will make the interpretation and convey the results to the patient.
