Preface

Nebraska Medicaid is supporting Hyper Text Transfer Protocol Secure (HTTP/S) in accordance with this guide.

This Submission and Connectivity Guide for real-time and batch 270/271 and 276/277 follows the CAQH CORE Phase I and Phase II guidelines along with the batch 835 for CAQH CORE Phase III guidelines. This Submission and Connectivity Guide is prepared for use by Trading Partners affiliated with Nebraska Medicaid. This Submission and Connectivity Guide is considered a living document, and as such, the information provided herein will be subject to change.

This Submission and Connectivity Guide to the Council for Affordable Quality Healthcare (CAQH) Committee on Operating Rules for the Information Exchange (CORE) Operating rules 153, 270 (Safe Harbor Connectivity) and 350 (Healthcare Claim Payment/ Advice) adopted under the Health Insurance Portability and Accountability Act of 1996 (HIPAA) clarifies and specifies the data content when exchanging transactions electronically with Nebraska Medicaid.

This Submission and Connectivity Guide is intended to convey information that is within the framework of the CAQH CORE Operating Rules 153, 270 & 350 adapted for use under HIPAA. The guide is not intended to convey information that in any way exceeds the requirements or usages of data expressed in the CAQH CORE Operating Rules 153, 270 & 350.

Two Trading Partner environments exist – one for test and one for production. The Trading Partner number for both environments will be the same. It is up to the Trading Partner to send the correct value in the ISA15 element and this must correspond with the environment they are submitting to.

The servers are available 24 hours a day, 7 days a week. The servers are supported by the DHHS EDI Helpdesk staff between the hours of 8:00 A.M. and 5:00 P.M. CT Monday through Friday, except State and Federal holidays. The contact for setting up a Trading Partner ID for electronic transactions is the EDI Help Desk at (866) 498-4357. All Trading Partner IDs will start with "XEC" and will be followed by a four-digit Trading Partner number, an environment letter and the Processing Mode.

Examples are:

XEC0018TB - Test batch mode

XEC0018PB - Production batch mode

XEC0018TRT - Test real time mode

XEC0018PRT - Production real time mode.





2.TRANSMISSION/RE-TRANSMISSION ADMINISTRATIVE PROCEDURES

Real-Time and Batch 270/271 and 276/277 transactions through HTTP/S: Real-time requests are limited to one inquiry per transaction. Batch 270 requests are limited to 99 patient requests within an ST/SE grouping. A response to the batch inquiry will be provided by 7 a.m. CT the following business day for batches received before 9 p.m. CT the previous day. Batch requests submitted after 9 p.m. CT will be available by 7 a.m. CT two business days following submission.

<u>Batch 835 transactions through HTTP/S:</u> All retrieval requests received from the Trading Partner through HTTP/S will be processed by NE Medicaid, provided the Trading Partners choose to receive the v5010 X12 835 Transaction. Acknowledgements sent by the Trading Partners will be accepted by NE Medicaid.

3.5 HTTP RESPONSES/ERROR MESSAGES

- **1. HTTP 200 OK** Returned when authentication is valid and request is accepted.
- 2. HTTP 202 Accepted Returned when batch file submission has been accepted.
- **3. HTTP 400 Bad Request –** Returned for incorrectly formatted HTTP headers.
- 4. Server Errors When the real-time production system is not able to process a real-time request due to interface failures or other system unavailability, a standard 5xx series error such as "HTTP 500 Internal Server Error" or "HTTP 503 Service Error" will be returned by the application. Resubmission is recommended at a later time.

3.6 ENVELOPE RESPONSES/ERROR MESSAGES

- 1. Success Envelope was processed successfully.
- **2. <FieldName>Illegal** Illegal value provided for <FieldName>.
- <FieldName>Required The field <FieldName> is required but was not provided.
- 4. Version Mismatch The version of the envelope sent is not acceptable to the receiver. If the SOAP version is not valid at the receiver, a SOAP fault is returned with this fault code.
- **5.** Checksum Mismatched The checksum value computed on the recipient did not match the value that was sent in the envelope (not applicable for retrieval request).
- **6.** Unauthorized Error Invalid user name and password.

3.7 BATCH RESPONSE AND RETRIEVAL

All batch requests for eligibility, batch requests for 835 and batch results acknowledgment will be received by establishing a HTTP connection using CORE rules. The Trading Partners must submit a request for available responses.

4.PASSWORDS

A unique user ID and password will be assigned by NE Medicaid EDI Helpdesk and must be included when sending a transaction to Nebraska Medicaid.
