2021 LEGISLATION UPDATES

Amy Reynoldson, Executive Vice President, with the NMA (Nebraska Medical Association) and Dexter Schrod, JD, VP Advocacy & Regulation, In-House Counsel, with the NMA, were present to discuss and provide updates to the Board on the Legislature. The 107th Legislature, Second Session convened January 5, 2022.

Dexter provided information on some of the legislative bills that the NMA is following that will be of interest to the Board:

- LB 753 Require health care practitioners to provide notification regarding stem cell therapy
(Requires a health care provider to obtain informed consent for human stem-cell based therapy that the patient understands the treatment is not approved by the FDA)

- LB767 Adopt the Pharmacy Benefit Manager Licensure and Regulation Act
(Prohibits PBMs and insurers from restricting pharmacies from disclosing any information they may deem appropriate for the patient to know, including the process of utilization review, any information on financial incentives or structures used by the insurer, the total cost of treatment or from presenting a more affordable alternative for the patient. PBMs are prohibited from requiring a patient to pay an amount greater than the lesser of the patient's cost-sharing or the amount a person would pay if paying for the cash price of the drug. Places restrictions on pharmacy auditing entities employed by PBMs. Prohibits PBMs from requiring information to be written on a prescription beyond what is required by law. Prohibits PBMs from placing a drug on a maximum allowable cost price list unless the drug is available for purchase from a wholesaler and is not obsolete. Prohibits PBMs from reimbursing a 340B entity at a rate lower than that paid for the same drug to similar pharmacies that are not 340B. Prohibits PBMs from excluding a pharmacy from the PBM's specialty pharmacy network if the pharmacy holds a specialty pharmacy accreditation.)

- LB885 Require implicit bias training for certain applicants and credential holders under the Uniform Credentialing Act
(Requires implicit bias training be completed annually for health care professionals)
NMA opposes this bill

- LB905 Provide for perinatal mental health screenings
(States that the Board of Medicine & Surgery may work with hospitals and licensed health professionals to develop policies, procedures, information, and educational materials on perinatal mental health disorders and screening)

- LB906 Require employers to provide for vaccine exemptions and provide duties for the Department of Health and Human Services
(Requires DHHS to create a vaccine exemption form for the public to fill out, and further requires employers who may institute a vaccine mandate to accept the exemption form as proof that an employee has a moral, ethical, or philosophical belief against the vaccine.)

- LB963 Adopt the Medical Ethics and Diversity Act
(Declares that health care practitioners, health care institutions, and health care payers have the right not to participate in or pay for any health care service which violates their conscience. Prohibits discrimination against such practitioners, institution, or payer for declining to provide a health care service based on their conscience. States that religious practitioners, institutions, and payers have the right to make employment, staffing, contracting, and admitting privilege decisions consistent with its religious beliefs.)

- LB1007 Change provisions relating to the Rural Health Systems and Professional Incentive Act
(Makes clear that no local match is required when federal law does not require a local match for student loan repayment funds)

- LB1044 Adopt the Care Team Innovation Grant Pilot Project Act and state intent regarding federal funds
(Creates a grant program for innovation in delivery of health care by hospitals and the ability to improve the health care workforce in the state. Focuses on health professionals being able to work to the fullest extent of their credential in a hospital.)

(Appropriates \$10 million in ARPA funds for the student loan payment program for health professionals practicing in rural shortage areas)

- LB1275 Adopt the Medicinal Cannabis Act
(Establishes a medical cannabis program for the following conditions: Stage IV cancer, uncontrolled seizures, muscle spasms caused by multiple sclerosis or muscular dystrophy, or a terminal illness with probably life expectancy of under one year)

Physician and Osteopathic Physician Reinstatement after Discipline Application(s) (3)

FRASER, JEFFREY, MD – application for reinstatement after discipline with early release from probation and dismissal of the civil penalty of his Physician license to practice medicine and surgery. Massey moved, seconded by Blake, to recommend denial for early release from probation and dismissal of the civil penalty. The basis for the denial is that there is insufficient evidence to change the original probationary period and or terms. Voting aye: Blake, Howorth, Keegan, Kuenning, Massey and Michaelis. JOHNSON, RAJITHA, MBBS – application for reinstatement after discipline and approval of the proposed reentry program to practice medicine and surgery. Massey moved, seconded by Blake, to recommend denial of the reentry program as proposed. Basis for the recommendation was that one of the proposed practice monitors is not acceptable due to active limitation of their license. KHEDIR AL-TIAE, TAREQ, MD – application for reinstatement after suspension of his Physician license to practice medicine and surgery. COVID 19 DISCUSSION

Governor Pete Ricketts on December 20, 2021 issued Executive Order (EO) 21-18 with continued waivers to facilitate hospital planning and ensure additional healthcare workforce capacity in Nebraska. EO 21-18 extends EO 21-15 issued October 13, 2021 and EO 21-12, issued on August 26, 2021 when declaring a hospital staffing emergency. EO 21-18 will remain in effect through March 31, 2022.
