Senator reviewed 38-1016 Cosmetology means the practice of performing for compensation any or all (1) of the acts of arranging, dressing, curling, waving, cleansing, cutting, bleaching, coloring, styling, or similar work upon the hair, wig, wiglet, or hairpiece of any person, by any means, with hands or a mechanical or electrical apparatus or appliance; (2) esthetics; (3) nail technology; and (4) other similar practices upon the hair, scalp, face, neck, arms, hands, feet, or nails of any person when performed for the purpose of beautifying or enhancing physical appearance or the teaching of any practice specified in this section for occupational purposes.

Statue indicates that if compensation is received not allowed.

LB561 - Adopt the Cosmetology Licensure Compact: establishes a multi-state licensing program for licensed cosmetologists in member states. It will increase mobility for said licensed cosmetologists within the member states of the compact while ensuring safe and reliable services to the public. Carryover bill. Floor debate Jan 9<sup>th</sup> with AM2071 filed. Recommend board follows LB561 and associated amendments.

**LB16** - Require occupational boards to issue certain credentials based on credentials or work experience in another jurisdiction, provide and change requirements regarding applicants with a criminal conviction, provide for jurisprudential examinations and appeals, change requirements for membership of the State Electrical Board, and adopt the Interior Design Voluntary Registration Act. Carryover bill, Feb 2<sup>nd</sup> Final Reading, then Enrollment and Review. Recommend board tracks LB16 and associated amendments.

**LB951** - Adopt the Public Officials on Private Boards Open Meetings Act. No impact on Cosmetology Board. No further action by board.

**LB955** requires any person, firm, partnership, association, limited liability company, corporation, or other business entity that sells gift cards or gift certificates to provide notice at the location where the sale occurs alerting customers to protect themselves from gift card scams. The notice will assist consumers in being more aware of gift card scams and will encourage vulnerable consumers to alert law enforcement if they believe they are being scammed. Recommend tracking.

**LB961** prohibits noncompete agreements for employees making less than one hundred thousand dollars annually. No action.

**LB 993** creates the Apprenticeship Grant Act assists individuals who are underemployed and receive economic assistance to become fully employed and selfsufficient by providing grants to qualified businesses who are partnered with a registered apprenticeship program and who provides on-the-job training and classroom instruction to the employee(s) enrolled in the program. Placed on general file Feb 13<sup>th</sup> with AM2373. Track

**LB1009** removes the limit of attempts allowed for the Barber Board Examination. Previously if an individual failed the examination three times, they would not be allowed to have additional attempts. LB1009 also aligns existing statute. No impact, licensure unit does not license or regulate barbers.
