**Program to Help Former Wards Transition** to Adulthood, Aug. 29, 2014 & Oct. 2, 2014

Children and Family Services recently launched Bridge to Independence, a program designed to help young adults who age out of state custody transition to adulthood.

In the program, also called b2i, 11 independence coordinators will provide guidance to former and current wards who will soon age out of the system. The hope is to provide the kind of support that other young adults get from their parents.

"Bridge to Independence enables us to provide resources that most young people inherently receive from their parents at this critical stage in their life," said DHHS CEO Kerry Winterer. "Through our program, we hope to help former wards live better lives as they journey to adulthood."

Independence coordinators, will be providing case management services statewide for former wards, said Thomas Pristow, director of DHHS' Children and Family Services. The youth will meet with them monthly and make their own life choices while coordinators provide developmentally appropriate services and help in developing an independent living plan aimed at reaching their goals.

Former state wards participating in the program will receive a monthly stipend to assist with

living costs such as housing, education Bridge to Independence and other Crossing from foster care into adult life? Take the Bridge to Independence. expenses. It's support, while YOU create the life YOU want

Some may qualify for Medicaid or will be given assistance in arranging health insurance.

"Hundreds of DHHS employees and stakeholders have worked thoughtfully and diligently to build a program that will give former wards the best chance to succeed after aging out of our system," Pristow said. "Thanks to their hard work, we now have the policies, regulations and materials in place to more effectively support former wards and have a better chance to be successful when they take their next step in life."

About 180 young adults 19-21 years old will be eligible to participate in the program this year.



Medicaid and Long-Term Care Poster Wins at Conference, Sept. 3, 2014

Medicaid and Long-Term Care's Ruth Vineyard, deputy director of initiatives and eligibility, and Jeanne Larsen, deputy director of claims, recently attended a conference in Denver which brings together leaders from the public and private sectors to discuss Medicaid systems and initiatives.

At the conference, Vineyard presented a poster on the Medicaid Management Information System (MMIS), which is the claims processing system for Nebraska's Medicaid program.

The objective of the poster was to represent Nebraska's vision for an enterprise MMIS solution using a number of resources and traditions specific to the state.

Medicaid and Long –Term Care staff used the state's links to Arbor Day and the Ogallala Aquifer to demonstrate how "Nebraska intends to plant seeds for a healthy Medicaid program and wisely use resources to grow an enterprise MMIS that will not only be sustainable, but reap benefits for future generations."

Vineyard's presentation of the poster earned Medicaid and Long-Term Care a first place award in the poster session's Original Content category.

#### First Puppy Snickers Promotes the Importance of Emergency Preparedness for Pets, Sept. 19, 2014



# **Coaching Winners!**

What are the characteristics of a good coach? When I facilitate discussions about how we as staff can help one another succeed, the responses I typically get sound like, "A great coach is..."

- A helper
- A champion
- A team leader
- Enthusiastic
- Goal oriented
- Supportive, and most of all...
- Someone who challenges me to do better than even I thought possible.

Let's think about that for a minute. My brain defaults to sports when I first think of coaching. I grew up playing organized sports and I am seeing some common language here. (I am six feet tall, so maybe it was more of a draft.) I am thinking: A coach plays the game along with me, from the sidelines, without putting on the uniform. That parallels our interpersonal relationships and how we experience coaching at work, both from our supervisors and our peers.

Sports coaches experience these same challenges because they don't touch the ball. That's our job as the players. They are seen as the decision makers, yet don't have direct control. They can see the big picture and have a strategies to accomplish goals, while it's up to us to perform. Their challenge is to motivate others to perform a combination of skills for a win.

I ran track and played basketball. I enjoy both individual and team sports, and for different reasons. When I ran track, all the responsibility and motivation had to come from within me. That is how I am wired. If something needs to get done, I just do it. That's not always a good thing, because it can make me want to take over projects, people, and teams. I think I am being assertive and "just" getting the work done, but where does that leave others? Others don't want to be "fixed" or "have us do it for them", they want to be "coached" helped along the way to do it right.

Now when I played basketball, it was altogether another story. We practiced as a group and we played as a group. That gave us the opportunities to learn how each other acted and reacted to situations. We were individuals, each with a different skill set. The magic came from how we differently practiced each of those skills and formed a team that could act and react as one. We learned plays and strategies which relied on our communication and relationships.
