#### 8) DD Updates

Courtney Miller presented updates to the committee on current events within the Division of Developmental Disabilities

- Medicaid Waiver implementation: 48% waiver participates have transitioned.
- Beatrice State Developmental Center: Current census is 109.
- *DD Court-Ordered Custody Act*: Currently 18 active DD Court-Ordered Custody cases. 13 are receiving Medicaid waiver services.
- *Waitlist*: Currently 1049 on the Registry and 2054 individuals on the Waiting list. Currently have 4,558 individuals receiving Medicaid DD Waiver services.
- State Business Plan DD Wait Times:
  - July 27, 2017 the DHHS Business Plan for July 2017-June 2018 was released and is available on the DHHS website. The Plan outlines Department priorities, defines goals, identifies deliverables, and measures progress.
  - Timely Access to Developmental Disability Services continued initiative from 2016-2017 year.
  - Next initiative is to ensure that timely access to services occurs once an opening on the Medicaid Home and Community-Based waiver because available and is offered, and the individuals accepts the service offer.
- Regulations: 403 Drafts have been posted and are being reviewed by DHHS Legal Counsel
