 - a) Supported Employment
 - (1) Upcoming summit on September 20
 - b) Legislation update

 - a) General
 - (1) Launched the new SDM intake Screening Tool for Child abuse and neglect reports
 - (2) In AABD, the standard of need for recipients in alternate living arrangements increased by \$11 to reflect the increase in personal care needs in LB227 as of September 1, 2023
 - b) Pandemic Electronic Benefits Transfer (P-EBT)
 - (1) P-EBT benefits for school-age children and fully virtual or homeschooled children were issued August 15, 2023
 - (2) P-EBT benefits for Summer 2023 are schedule for September 12 for the Omaha Metro area and September 14 for all other school districts.
 - c) Supplemental Nutrition Assistance Program (SNAP)
 - (1) The gross income limit will remain at 165% of the Federal Poverty Level (FPL) through September 30, 2025
 - d) Refugee Resettlement Program (RRP)
 - (1) RRP helps newly arrived refugees and other eligible populations establish new life and self-suffienciency following their arrival in the U.S.
 - (a) Eligible refugees can receive cash assistance and medical coverage for up to 12 months upon arrival
 - (2) DHHS contracts with Refugee Social Service agencies to provide supportive services, including job preparedness, English as a second language classes, and other supportive services.
