- 1) Division of Behavioral Health
 - a) Certified Community Behavioral Health Clinics (CCBHC) Overview
- 2) Division of Child and Family Services
 - a) Protection & Safety
 - (1) Biden-Harris administration release <u>three new rules</u> for state child welfare agencies
 - (a) The three rules will support kinship caregivers, protect LGBTQI+ children in foster care, and expand access to legal representation for children and families in the child welfare system.
 - b) Low Income Home Energy Assistance Program (LIHEAP)
 - (1) The LIHEAP heating season begins Oct. 1st, 2023; Heating assistance eligibility will be determined starting the same date
 - (2) DHHS does not expect to receive federal LIHEAP funds until November, as is typical
 - c) Low Income Household Water Assistance Program (LIHWAP)
 - (1) LIHWAP was extended; DHHS will be accepting applications through ACCESSNebraska through the end of February 2024
 - (2) Oct. 1st, 2023 will begin the new year. Thus, households that have received LIHWAP can request assistance again starting then.
 - d) Disabled Persons and Family Support (DPFS) Program
 - (1) Effective September 2, 2023, Neb. Rev. Stat. §68-1512 was amended under the passing of LB 227. LB227 increased the maximum support allowable under the DPFS program to \$400 per month per disabled person, averaged over the approved 12-month eligibility period.
 - (a) Or \$400 per month per family averaged over any 12-month eligibility period for the first disabled family member plus \$200 per month averaged over 12 months for each additional disabled family member.

- (2) The DPFS program maximum support allowable for eligible clients in a 12-month eligibility period is now \$4,800.
- e) Supplemental Nutrition Assistance Program (SNAP)
 - (1) Pandemic EBT (P-EBT) benefits for Summer 2023 were issued on Sept. 12th and 14th.
 - (2) Additional clean-up issuances are being scheduled for this fall; clean-up issuances include families that were missed in the original issuances.
