 - CMS responded December 2020, and their comments were incorporated into the document.
 - The document was resubmitted January 7, 2021.
- Monitoring of previously assessed settings began January 2021.
 - Monitoring will be done virtually at least through June 30, 2021.
 - Agencies will be contacted each month by the assigned reviewer to schedule monitoring assessments.
- Project to assess settings that were not previously assessed was completed December 2020.

- On December 18, 2020, DDD sent a summary of proposed updates to Appendix C: Participant Services for DD agency providers to have an opportunity to provide feedback on proposed revisions.
- The proposed updates were the result of not having a consolidated day service.
- In Appendix B-6: Evaluation/Re-evaluation of Level of Care, DDD is replacing the Developmental Index (DI) with the Inventory for Client and Agency Planning (ICAP) and the Behavioral Risk Screen.

- An extension to Appendix K for all four Medicaid HCBS waivers was approved by CMS December 17, 2020
- The new end date is March 5, 2021.
- For the Developmental Disabilities Adult Day Waiver and Comprehensive Developmental Disabilities Waiver, the extension continues to allow the same flexibilities in service delivery and service plan development, but does not include a rate increase to providers for services.
- For the Aged and Disabled Waiver and Traumatic Brain Injury Waiver, the extension continues to allow the same flexibilities, but does not include a payment increase for assisted living facilities.

- The DD Policy Manual was implemented August 15, 2020.
- The manual outlines the requirements and procedures for Medicaid Home and Community-Based (HCBS) Developmental Disabilities (DD) Waiver services.
- The manual arranges requirements and procedures into a comprehensive single document. *All providers of DD services must comply with this manual.*

DD Policy Manual Update

- The DD Policy Team updates the DD Policy Manual.
- A DD agency provider group was given the opportunity to review and comment in October 2020.
 - This group was based on membership in the original provider group during the drafting stage.
 - If an agency provider was not included in this group, and would like to be included during future revisions, send an email to DDD.
- The Public Comment period was December 1-30, 2020. Emails were sent to provider and stakeholder groups. A draft and summary of changes was posted.

- The DD Policy Team is currently reviewing information received during the public input process.
- DDD will post a summary of public comments.
- The summary will specify any changes made to the DD Policy Manual as a result of the public comment process and include reasons why any recommendations were not adopted.
- Revision should be complete and effective January 2021.
- June 2021 is expected to be the next public comment period for revisions to the DD Policy Manual.

ICAPs During COVID-19

- Administering ICAPs during the pandemic is challenging.
- Our waivers and regulations require an ICAP will be completed every two years after initial entry in to services.
- The biennial ICAP is designed to assess the participant's current skills, abilities and behaviors.
 - We use a 30 day time period prior to the ICAP interviews, although our ICAP manual does allow discretion to adjust that time period to get an accurate picture of the individual's needs.
- When the participant's needs change significantly before the next scheduled ICAP, the ISP team can request a new ICAP.





Legislative Background

In <u>Olmstead v. L.C.</u> the Supreme Court ruled people with disabilities have a right to lives of inclusion and integration. Disability is a normal part of life and we all benefit from communities made up of diverse people, life experiences, and abilities.

The court required states to provide services in the community to people with disabilities when:

- The services are appropriate;
- The person does not oppose community-based services; and
- The community-based services can be reasonably accommodated, taking into account the resources available and the needs of others receiving services.
