### Technical Assistance Conference Calls for Independent Providers of Developmental Disabilities Services

The Division of Developmental Disabilities Provider Relations staff conducts technical assistance question and answer Conference Calls, twice a month. These are not required, but are offered to assist with any questions you may have. Questions may be submitted in advance to Katie Weidner or Kim McFarland, or may be asked during the call. Pre-submitted questions will be answered at the beginning of the call.

Calls are held on the second and fourth Tuesday of every month. The second Tuesday is held from 12:00-1:00 pm CST and the fourth Tuesday call is held from 7:00-8:00 pm CST.
