### **Project Background**

- DHHS engaged CBIZ Optumas and Myers & Stauffer LC to perform a rate study encompassing:
  - Aged and Disabled (AD) Waiver services;
  - Traumatic Brain Injury (TBI) Waiver services; and
  - Personal Assistance Service (PAS) on the Medicaid State Plan.
- Providers had the opportunity to participate in a cost survey, reporting the cost of delivering Waiver and/or PAS services. The survey closed June 24, 2022.
- CBIZ Optumas is developing rate model recommendations for consideration. These recommendations are intended to help DHHS set future rates, subject to appropriations from the legislature and approval from federal partners.
- The rate models presented today are DRAFTS and may change with additional stakeholder feedback.



### **Stakeholder Feedback Themes**

- General agreement with higher rate recommendations than existing rates.
- Suggestions:
  - Rate models for Assisted Living Facility Urban and Rural should be similar or the same.
  - Create a separate Memory Care rate for Assisted Living Facility.
  - Consider different assumptions for staffing ratios.

### **Updates to Draft Assisted Living Facility Rates**

- Overall costs for Assisted Living Facility are similar between urban and rural settings.
  - Based on cost report data and BLS wage data
  - Feedback from providers confirmed
- The draft rate models for Assisted Living Facility Rural Single Occupancy and Urban Single Occupancy have been set equal.
  - The following slides show the equal draft rate models
- Memory Care has not been separated, as data is not robust enough to support a separate rate model.

### **Updates to Other Draft Rate Models**

#### Respite and Extra Care for Children with Disabilities

- Feedback: while these services are often delivered at a 1:1 staffing ratio, actual staffing ratios can vary.
- The draft models have been broken out to reflect 1:1, 1:2, and 1:3+ staff to participant ratios.
