 (1) Responsible for all the Service Area Administrators and field operations
- b) Confirmation hearings for Director Bish scheduled for next week.

3) Office of Economic Assistance

- a) Child Care and Development Fund (CCDF):
 - (1) On December 18, 2023, the Restoration Enhancement Program and Technology Access Program grants funded by American Rescue Plan dollars were successfully launched. Over 700 applications were submitted in the first 10 days of the application period.
 - (2) Monthly child care grant applications, including Start-Up Expansion, Emergency, and Quality Improvement, doubled in December.
- b) Supplemental Nutrition Assistance Program (SNAP):
 - (1) The final issuance of P-EBT occurred on December 14, 2023. There are currently no additional issuances scheduled.
- c) Low Income Home Energy Assistance Program (LIHEAP):
 - (1) The heating season started October 1, 2023, and ends March 31, 2024.
- d) Low Income Home Water Assistance Program (LIHWAP):
 - (1) LIHWAP aid funds have all been expended, and applications are no longer being accepted.
