Registration

How do I register for the Prescription Drug Monitoring Program (PDMP) if I am in Nebraska?

How long does it take to be approved after I register for the PDMP?

- The entire process to register and authenticate access can take up to 2 weeks. The email will be coming from CyncHealth Secure (support@cynchealth.org) with a subject line of "Welcome to CyncHealth!". If you do not see the email in your inbox, please check your SPAM or junk mail folder.
- If you are still not getting the email, check with your IT Department to ensure that the email CyncHealth Secure (support@cynchealth.org) is "white-listed" so any company related filters are not blocking this email.

I have tried to reset my password, but I have not received the password reset link.

- The reset link is typically sent within 4 hours of the reset request. The email will come from CyncHealth Secure (support@cynchealth.org) with a subject of "Account password reset". If you do not see the email in your inbox, please check your SPAM or junk mail folder.
- If you are still not getting the email check with your IT Department to ensure that the email CyncHealth Secure (support@cynchealth.org) is "white-listed" so any company related filters are not blocking this email.

I had a PDMP account with another employer and now I don't have access to that email anymore. What should I do?

If you would like to change the email associated with your PDMP account, or if you no longer have
access to that email you will need to request an email change through CyncHealth. This can easily be
done by completing the form from this link <u>https://cynchealth.force.com/s/pdmp/pdmp-email-changerequest</u>. Once that is submitted, the email address will be updated and password reset email will be
sent to the new email address.

Missing or Updating Information

I can't find a patient that should be in the PDMP.

• If you are unable to locate a patient in the PDMP, try entering a partial first and last name with a wildcard (*) along with the patient's date of birth.

• If you are still unable to find a patient using the wildcard search, you may need to contact the pharmacy(ies) the patient uses to verify how the pharmacy entered the patient's name into the PDMP.

What do I do if there are dispenses missing from the PDMP?

- The PDMP is a reflection of what is submitted by pharmacies and should be updated within 24 hours of the prescription being sold or picked up by the patient. If items are missing after this timeframe, reach out to the pharmacy to ensure that the information on the dispensed label matches the patient's information.
- If this does not resolve the issue, open a ticket for the patient inside the PDMP. For instructions on how to open the ticket, please review the PDMP RXGov Tickets video found here: https://dhhs.ne.gov/Pages/PDMP-Enhancements.aspx.

What do I do if there are multiple profiles for the same patient? How do I merge patient profiles?

- Search for the patient (including using the wildcard *) and date of birth, select the profiles and click on "Flag for Patient Merge" this will open a ticket to the administrators to address the issue.
- If the patient has multiple profiles but different first and last names, select the most accurate profile and open a ticket to include other spellings or Patient IDs.

Updates

How often is the PDMP updated?

• The PDMP is a reflection of what is submitted by pharmacies and should be updated within 24 hours of the prescription being sold or picked up by the patient.

How often is the query history updated?

• The query history is updated each time you log in and when you click on the refresh button on the query history tab. If you've looked up a number of individuals during the day and want to go back, click on the refresh button to reload that information.
