## **Brief Screenings, Provider Talking Points and Referral Options**

If you have a patient that you are concerned may have a drug misuse issue here are some quick references that may help you care for your patient and/or refer them to needed services:

# **Brief Screenings**

If you are looking for a screening tool to assess your patient:

National Institute on Drug Abuse (NIDA): Talking to patients about their drug use

#### **Screening tools:**

Screening and Opioid Assessment for Patients in Pain-Revised— SOAPP-R (24 Questions 0-4 scale) or SOAPP Opioid Risk Tool — ORT (10 questions)

Pain Assessment and Documentation Tool— PADT (assesses analgesia, ADLs, Adverse Events and Potential Aberrant Drug-related Beh.)

Current Opioid Misuse Measure— COMM (17 questions 0-4 scale)

Prescription Drug Use Questionnaire—PDUQ (31 Yes/No Questions)

Based on results of screening refer to below decision tree to help guide appropriate referrals




Figure 1. Algorithm for management of substance misuse in primary care.
