## Presumptive Eligibility Training Quiz

## True/False Questions:

- 1. Presumptive eligibility may be approved for anyone that is potentially Medicaid eligible.
- 2. Presumptive eligibility determinations are limited to once per two calendar years, or once per pregnancy.
- 3. Pregnant women approved for presumptive eligibility are limited to ambulatory care only.
- 4. Individuals have two months from the date of their presumptive determination to file an application.
- 5. Completing and submitting the Hospital Presumptive Determination Form serves as a valid application for an individual for Medicaid.
- 6. Individuals should furnish proof of citizenship or qualified non-citizen status when completing a presumptive determination.
- 7. Pregnant women without legal non-citizen status may not be approved for presumptive eligibility and must file a full Medicaid application.
- 8. Only the income of the parents is counted in the income calculation.
- 9. A minor parent living with his/her parents must be counted in his/her parents' household.
- 10. Verification of pregnancy is required for presumptive eligibility determinations.

## Household Size Questions:

- 1. Mary is a 56-year-old working grandmother who claims her daughter Samantha, age 18 and a full-time student, and her granddaughter Joy (Samantha's daughter), age 2, as tax dependents. No one in the home is pregnant. No one in the home has health insurance. Joy is the household member in need of a presumptive determination.
  - a. What is the household size for Joy?
- 2. Alice is a 66-year-old working grandmother who has her 12-year-old grandson Bill living with her. Alice does not plan to claim Bill as a tax dependent. Bill received Social Security Survivor benefits, and he is not expected to file taxes. No one in the household is pregnant. Alice received Medicare benefits, and Bill has no health insurance. Bill is the household member in need of a presumptive determination.
  - a. What is the household size for Bill?
- 3. Household consists of Kelly (age 45), her partner Stanley (age 47), Kelly's 15-year-old son Isaac, Stanley's 14-year-old son Trent, and Stanley and Kelly's 2-year-old son Jacob. Kelly claims Isaac as a tax dependent. Stanley claims Trent and Jacob as tax dependents. No one in the household is pregnant. No one in the household has health insurance. Trent is the household member in need of a presumptive determination.
  - a. What is the household size for Trent?

- 4. Household consists of Doug (age 50), his daughter Elizabeth (age 18), Elizabeth's husband Andrew (age 19), and Andrew and Elizabeth's son Sam (age 1). Doug claims Elizabeth as a tax dependent, and Andrew claims Sam as a tax dependent. All family members live together. No one in the household has medical insurance. Elizabeth is pregnant and is expecting twins. Andrew plans on claiming the twins as tax dependents after they are born. Doug is the household member in need of a presumptive determination.
  - a. What is the household size for Doug?
- 5. In the same household listed in #4, Elizabeth is the household member in need of a presumptive determination.
