### **Please share this information with professional, administrative and billing staff.**

This provider bulletin is effective with the implementation date, upon CMS approval, of the new Medicaid HCBS DD Adult Day Services Waiver (0394) and Comprehensive Services Waiver (4154). This implementation date is anticipated to be March 1, 2017. New services have been created as a result of unbundling services from the previous waiver services.

Current agency providers will be automatically enrolled in all new services that crosswalk to the old services they were authorized to provide. If a current agency provider would like to provide a service that is not crosswalked from an old service they provide, the provider must enroll through Decision Point in Maximus.
