RE:	Over-the-Counter (OTC) Drugs Coverage Changes

This provider bulletin (PB) is being issued to notify Medicaid providers of upcoming changes to the coverage of certain over-the-counter drugs.

On January 1, 2017, the pharmacy benefit was predominantly carved into Nebraska's Medicaid managed care program, Heritage Health. Certain over-the-counter products are covered through Heritage Health when prescribed by a Nebraska Medicaid enrolled provider.

The Administrative Simplification Committee made a recommendation to increase simplicity and uniformity among the Heritage Health Plans' OTC coverage. A standardized list of covered OTC products has been developed and will be posted on each Heritage Health Plan's website in December 2018.

On January 1, 2019, a standard OTC list will be implemented by each Heritage Health Plan. Medicaid will only cover products whose manufacturers participate in the Federal Medicaid Drug Rebate Program. Products which are supplied by manufacturers who do not participate in the rebate program will no longer be covered. Several chain store brands will fall into this category. Some individual National Drug Code (NDC) numbers which Medicaid previously covered will no longer be covered and will need to be replaced with rebateable NDCs. Check the list posted on your Heritage Health web site to find alternative products if a brand previously utilized is not covered. Listed below are links to the OTC lists:
