**Re:** Nebraska Medicaid Expansion Heritage Health Adult (HHA) Update & Educational Webinar

HHA expands Medicaid to lower income adults (age 19 to 64) who earn up to 138% of the federal poverty level. Nebraska Medicaid will begin accepting applications for HHA on August 1, 2020. Benefits will begin on October 1, 2020.

Please note that some HHA beneficiaries will receive their Medicaid Cards prior to October 1, 2020. Coverage for HHA does not begin until October 1, 2020. Providers are reminded to check patient eligibility prior to rendering services.

The Medicaid and Long-Term Care (MLTC) Division will be hosting a one-hour educational webinar for providers on the implementation of Medicaid expansion in Nebraska, also known as Heritage Health Adult (HHA). Providers may choose from the following ten (10) webinar options. Each session is identical so please choose the one that is most convenient for you.
