# SFY 2021 Aging & Disability Resource Center Fund Allocation

#### Introduction

This document describes how the Aging & Disability Resource Center (ADRC) funds are allocated for State Fiscal Year 2021 (July 1, 2020 – June 30, 2021). In the past, participating Area Agencies on Aging (AAAs) elected to split funding evenly. Funds were divided into seven equal parts. The seven participating agencies are:

- 1. Aging Office of Western Nebraska
- 2. Aging Partners (Lincoln Area Agency on Aging)
- 3. Blue Rivers Area Agency on Aging
- 4. Eastern Nebraska Office on Aging
- 5. Midland Area Agency on Aging
- 6. Northeast Nebraska Area Agency on Aging
- 7. South Central Nebraska Area Agency on Aging

With State Fiscal Year 2021, ADRC Partner Organizations (APOs) will begin providing ADRC services. The APOs for SFY 2021:

- 1. Brain Injury Alliance Nebraska
- 2. Easterseals Nebraska
- 3. League of Human Dignity
- 4. Munroe Meyer Institute

### Definitions

**Disability:** A long-lasting physical, mental, or emotional condition. This condition can make it difficult for a person to do activities such as walking, climbing stairs, dressing, bathing, learning, or remembering. This condition can also impede a person from being able to go outside the home alone or to work at a job or business. (U.S. Census Bureau Glossary)

Older Adult: An individual that is 60 years or older (Older Americans Act, Section 102 (40)).

### Funding Goals

- 1. Equitably split ADRC funding between AAAs and APOs.
- 2. Equitably split current ADRC funding among participating AAAs.
- 3. Equitably split ADRC funding to APOs.

## Aging & Disability Equitable Split

Older Nebraskans and Nebraskans with disabilities are not two distinct groups. Some individuals are considered both an Older Nebraskan and a Nebraskan with a disability. The first step is to identify:

- 1. Number of Nebraskans with a disability
- 2. Number of older Nebraskans
- 3. Number of Nebraskans represented in both categories

The American Community Survey (ACS) (2013 – 2017) S1810, disability characteristics and the decennial census (2010) were used.

According to the decennial census (2010), there were:



\* Because of the different survey years, Nebraskans with a disability will have a slightly higher population (there were more people to count).

\*\* Note: ACS 2017, uses 65+ years as the Older Nebraskan definition. Those that are 60 – 65 years old are considered "Nebraskans with a disability" only in this table.

It is assumed that Aging (AAAs) will serve those that are considered both an Older Nebraskan and a Nebraskan with a disability.

#### The State will split the SFY 2021 ADRC Aid (\$613,912):

Population Description	Percent of Initial ADRC Award	Amount of ADRC Award
Older Nebraskans <b>(AAAs)</b> + Both older Nebraskan* & Nebraskan with a disability	86%	\$527,964.32
Nebraskans with a disability** (APOs)	14%	\$85,947.68

#### Split reasons:

- The overlap of Older Nebraskans & Nebraskans with disabilities starts at 65 years, not 60 years.
- Due to the different survey years, Nebraskans with a disability will have a slightly higher population (there were more people to count).
- Current legislation requires all funding to go through AAAs to APOs. AAAs will have some costs associated with managing the funding APOs receive.
- APOs are starting to provide ADRC services and are in the process of establishing programs.
- This is more funding than previously designated for APOs.
- The Award percentages can be adjusted to meet future needs.
- If more funding is received, this document will be updated with additional information.

## Equitable split for AAAs

In previous years, ADRC funding was split evenly among participating AAAs. Each participating AAA received the same award amount (approximately \$87,701) regardless of:

- Population size
- Number of service units provided

The State will set aside 1.89% of the AAA funding amount (\$527,964.32) for the AAA that acts as the "pass-through entity" for an APO. This is approximately \$9,978.53. It will be awarded to the AAA(s) managing the APO funding.

The remaining balance (\$517,985.79) will be split using a base (guaranteed amount) and the remaining funds allocated using the Community Aging Services Act (CASA) funding formula percentages.

A 13% base award amount is established. Each participating AAA will receive a minimum \$68,635.36. The remaining 7.11% of the AAA Award Amount will be divided using the CASA funding formula percentages.

While the aging community and those with disabilities face similar challenges and use similar services, the approach to meet these population needs are different.

The State utilized a list based on the Centers for Medicare & Medicaid Services (CMS) identified Chronic Health Conditions (CHCs) that often relate to a disability designation. Each APO identified the CHCs that their organization provides services to:

There is CHC service overlap. For example, the League of Human Dignity, Easterseals Nebraska, and Brain Injury Alliance of Nebraska could each provide services to an individual with a Traumatic Brain Injury.

In order to create a whole, the maximum number of CHCs (27) was multiplied by the total number of APOs (4), for a product of 108. Each APO CHCs Served was divided by 108.

The remaining 0.361111 is split evenly as a built-in base for each APO.
