RE: Nebraska Medicaid Excluded Providers List

**Please share this information with administrative, clinical, and billing staff.**

Nebraska Medicaid is required to notify local offices and the general public when a provider has been sanctioned. This is accomplished through the posting of the Nebraska Medicaid Excluded Providers list (NMEP): <http://dhhs.ne.gov/medicaid/Documents/Excluded-Providers.pdf>. This list is separate and in addition to the Office of Inspector General List of Excluded Individuals and Entities (see Provider Bulletin 09-02).

Excluded persons/entities are not allowed to submit claims for payment – directly or through any clinic, group, corporation, or other association – for any services provided, ordered, or referred by that person/entity (471 NAC 2-002.05A). If any claims are submitted, civil penalties could be imposed or criminal prosecution could occur. Excluded persons/entities are also prohibited from associating with an enrolled provider (471 NAC 2-002.02).

Excluded persons/entities may request removal from the NMEP. Providers that want to reactivate participation as an enrolled provider with Nebraska Medicaid may initiate the NMEP removal process by submitting a new Service Provider Agreement through Maximus at: [www.nebraskamedicaidproviderenrollment.com](http://www.nebraskamedicaidproviderenrollment.com). A request to be removed from the NMEP without reactivating enrollment can be done by submitting the Nebraska Reactivation Questionnaire: <http://dhhs.ne.gov/medicaid/Documents/NE-Reactivation-Questionnaire.pdf> to Program Integrity at [DHHS.MedicaidProgramIntegrity@nebraska.gov](mailto:DHHS.MedicaidProgramIntegrity@nebraska.gov).
