#### Eric Berggren, P.E.

# Chairman's Report Nebraska State Board of Health - 2008 Linda Lazure, PhD, RN

In 2008, members of the Board of Health (BOH), representing a variety of health care providers and the public, continued to serve the citizens of Nebraska by providing expertise and advice on health issues to the Nebraska Department of Health and Human Services (DHHS). The Board's vision, "healthy people in a healthy Nebraska", has guided our mission as we promote and protect the health and safety of Nebraska citizens in the following areas:

- Regulatory and legislative issues
  - The Rules and Regulations Committee reviews regulations that are slated for either approval or review by the Board of Health. The committee has prioritized the work of the regulations necessary to implement the Uniform Credentialing Act (UCA), which became operative on December 1<sup>st</sup>, 2008. This is a major effort for many DHHS staff and professional board members.
  - The Credentialing Review Committee, which reviews credentialing or scope of practice proposals, has been challenged by another year of impressive assignments.
    - A Technical Review for Certified Registered Nurse Anesthetists and the use of fluoroscopy was completed in early 2008.
    - The Board is winding up a credentialing review on Dental Assistants, which started in April 2008. This review was closely watched by many, as the outcome affected draft regulations originated by the Board of Dentistry. The Board of Health tabled the dental regulations pending the outcome of the credentialing review. Janet Coleman, public member on the Board of Health, serves as Chair of the Technical Review Committee.
    - A review of Macro Social Workers started in the fall of 2008, chaired by Roger Reamer, Hospital Administrator on the Board of Health.
    - A review of Gambling Assistance Counselors started in August, 2008, chaired by Ed Discoe, MD on the Board of Health.
    - The Committee proposed to establish a Credentialing Review Public Member Pool. The Professional Boards Committee set criteria, conducted interviews, and recommended ten individuals to the full Board of Health to appoint. An orientation session was conducted, and this effort will streamline the recruitment process for the public members who serve on technical review committees.
    - Other potential upcoming reviews: Optometry, Radiology, Polysomnographers, and Surgical Technicians.
  - The Public Health, Education and Legislation (PHEL) Committee provides a forum for the discussion of legislative issues

- At most Board of Health meetings, a DHHS representative updates the members about legislative issues.
- Members share their profession's views of legislative issues and work collectively to craft positions that the entire board can support.
- November election ballot the issue of opting out of newly mandated water fluoridation for communities or municipalities with a population of 1,000 or more. To encourage voters to make an informed vote, we sent letters to over 200 newspaper editors across the state urging them to print articles in their local papers to help educate their readers on the provisions of the "opt out" and to encourage them to "vote no to tooth decay." The letter was printed in several newspapers, but in the end, 53 of 67 communities unfortunately voted to opt out of water fluoridation.
- O This year in addition to taking a formal position of supporting various bills, I have provided testimony or sent a letter on behalf of the Board, to the Unicameral's Health and Human Services Committee for: LB 205 (adopt the Bullying Awareness policy); LB 245 (Fluoridation of drinking water); LB 395 (Clean Indoor Act); LB 807 (Medicaid coverage of Tobacco Cessation products); and LB 836 (Prohibit smoking in a vehicle with a minor present).

#### • Professional Boards

- The Professional Boards Committee has been working diligently to increase the efficiency of the interview process while providing a welcoming atmosphere for applicants during the interviews. Interviews were held this fall in both Kearney and Lincoln. Board of Health members used a new electronic process this year, helping our environment by wasting less paper and at the same time increasing the efficiency of how professional board applications are processed and reviewed.
- Recruitment of professional board applicants was done this year largely through news releases, web site postings, and emails, moving away from the thousands of direct mail letters that were sent to licensees in the past – again, helping the environment and at the same time saving tax payer dollars.
- I am so grateful and impressed regarding the amount of time and effort that so many of the Board members generously donated to this entire process.
- As a former chair of this committee, I continue to be active and attend each regular meeting and participate in every interview session.
- Each Board member is strongly encouraged to serve as a liaison to specific professional boards and provide information to the rest of the committee and Board. I have attended meetings of the Boards of Nursing, Advanced Practice Nursing, and Cosmetology this year.

#### • Educational health programs

- o Besides providing a legislative discussion forum, the Public Health, Education and Legislation (PHEL) Committee offers a mechanism for ongoing board member development by scheduling presentations over topics related to public health assessment, policy development, and public health assurance.
- The PHEL committee can recognize public health programs and providers who offer exemplary service via the Community Public Health Recognition program.
- The Board of Health is very interested in helping educate the public about pertinent health issues that exist in this multi-faceted state.
- As in previous years, the Committee has provided educational opportunities during the annual "out-of-Lincoln" meeting, which include tours of local hospitals and meetings with local public health professionals. This year's meeting was held at Good Samaritan Hospital in Kearney.
- Public health assessment, policy development, and assurance
  - Several members continue to serve through the Nebraska Center for Nursing Board, Turning Point, Public Health Law Committee, as well as other policy boards.
  - O Besides participating in the work of the standing committees, three members serve at a time on an ad hoc Review Panel that investigates when an issue concerning a professional board arises. When presented to the Board of Health, the Review Panel becomes "prosecutors" and the rest of the BOH becomes "jurors". Fortunately, this panel has not had to meet this past year.
  - The Board of Health is grateful to the DHHS staff members who continue to educate the members about the intricacies of public health.

#### Communication/coordination

- o In January, the Board of Health invited key senators and legislative staff to a luncheon at Billy's. We will do this again in January 2009 to help provide an educational opportunity for new senators as they begin their terms. The Board of Health members hope to continue to provide them with advice on health care issues to all members of the Unicameral.
- The BOH plans to continue to build communication bridges with professional boards and chairs. Several incumbent professional board members shared concerns about investigative timelines and decisions and provided the Board of Health with data for subsequent conversations with Department officials to help address those issues.

The Board's role in the Department of Health and Human Services continues to be defined and developed. The members are appreciative of Dr. Schaefer's and Dr. Acierno's leadership.

The people of Nebraska continue to be well served by the Board of Health. The Board continues to be committed to the citizens of Nebraska and, through its very dedicated members, continues to provide very important services to the citizens of this state. We were pleased to welcome five new members in 2008, and have Dr. Paul Salansky reappointed to the Board of Health. In addition, the DHHS staff continues to provide excellent support to make this possible, and we all applaud and thank them for their service.

- Meetings held the third Monday of odd months, except fourth Monday in January.
- September 2007 the Board met in Nebraska City. September 2008 in Kearney.

#### PROFESSIONAL BOARD APPOINTMENTS:

- 133 applicants; 77 interviewed; 50 appointed in 2008, including the 10 members appointed to the Credentialing Review Public Member Pool.
- Met with 3 professional board chairs.

- 17 sets approved; 7 sets reviewed in 2007. Anticipate 60 sets in 2008.
- Received a presentation on the 150 mile nursing home administrator rule.

# Highlights of the Nebraska State Board of Health For Year 2008

The Nebraska State Board of Health worked harder than ever during 2008. They conducted six regular meetings, including one held in Kearney. There was a separate meeting for the Public Health, Education and Legislation Committee to review bills introduced at the start of the session. The Professional Boards Committee conducted interviews of professional board applicants on two non-regular meeting days, in addition to regularly scheduled committee meetings held on the public meeting days. There was a special meeting in April for approval of regulations. Members assigned to the Credentialing Review Committee and their Technical Review Committees had several meetings to attend. There were also several separate meetings of Board members to meet with their professional associations, professional boards, community organizations, legislative representatives, and the Department of Health and Human Services leadership.

It was a year of turnover for the Board of Health members. Dr. Dale Michels attended his first meeting in January. Dr. Sam Augustine resigned in June to serve as the President Elect of the Nebraska Pharmacists Association, and Dr. Ken Kester was appointed to serve the remainder of his term. Tim Crockett, PE, Clint Schafer, DPM, and Gwen Weber, PhD, completed their five-year terms. Eric Berggren, PE, John Tennity, DPM, and Dan Bizzell, EdD were appointed to these positions by Governor Heineman. Kent Forney, DVM left the Board of Health following successful completion of two full terms, and Ted Evans, DVM was appointed to replace him.

November 17, 2008 was Dr. Linda Lazure's last day as Chair of the Board of Health. Her term on the Board will be up in August 2009, so she did not seek reappointment. Dr. Ed Discoe was elected as the new Chair, Dr. Gary Westerman was re-elected for his second term as Vice Chair, and Dr. Paul Salansky was elected as Secretary for 2009. They make up the Executive Committee, along with David Montgomery from DHHS.

Staff for the Board remains the same: David Montgomery continues as the Executive Administrator, and Monica Gissler continues as the Program Manager. Committees are staffed by Ron Briel (Credentialing review), Joyce Davidson (Rules and Regulations), Monica Gissler (Professional Boards), and Jeff Soukup (Public Health, Education and Legislation). Anne Owens provides additional support for the Board.

On January 28<sup>th</sup> Board of Health members again hosted a legislative luncheon, this year at Billy's Restaurant in Lincoln. Members of the Health and Human Services Legislative Committee and key staff were invited. This meeting was a good opportunity to meet new senators, and to provide some education on Board of Health activities.

The Board met at the Good Samaritan Hospital in Kearney on September 15<sup>th</sup>. Professional Board interviews were conducted the previous day in Kearney. Columbus Hospital will host the Board of Health for the September 21, 2009 meeting. When the Board of Health meets outside of Lincoln, they still conduct all regular Board business, including scheduling a day to conduct professional board interviews.

Dr. Westerman attended the New Professional Board Member Orientation session conducted by Licensure Unit staff in Lincoln in December. He provided an overview of Board of Health activities as they relate to professional board members.

Two members (Pam List and Roger Reamer) serve as liaisons to the Turning Point Public Health Collaboration through the Office of Public Health. Ms. List also serves on the Public Health Law Team, the Rural Health Advisory Commission, and the Nebraska Center for Nursing Board. In 2009 the Board of Health will review and approve approximately 60 sets of rules and regulations necessary to implement the Uniform Credentialing Act.

Attachment I is a complete listing of members and standing committees.

Activities and duties taking the most time and attention for Board members during 2008 include:

- 1. Appointments to professional boards, including enhancement of an applicant screening tool and use of electronic means to more effectively share information;
- 2. Attending individual professional board meetings;
- 3. Review and/or approval of agency rules and regulations;
- 4. Public health initiatives, including identifying current risk behaviors
- 5. Participation in the Credentialing Review Program (407) reviews;
- 6. Writing informative articles for various public health newsletters;
- 7. Providing testimony before legislative hearings and in writing; and
- 8. Ongoing review of statutes and by-laws affecting the governing of the Board.

The Board of Health greatly appreciates the support of Dr. Joe Acierno, Deputy Chief Medical Officer of the Division of Public Health. He attended five Board of Health meetings in 2008. The Board also appreciates the written report of current public health events provided by Dr. Joann Schaefer for each meeting.

#### PROFESSIONAL BOARDS UPDATE:

The Board of Health has a statutory requirement to appoint members to serve on 28 health care professional boards managed by HHS Regulation and Licensure. One new board was created in 2008: the Board of Medical Radiographers, which replaced the Medical Radiography Advisory Committee. The Board of Health is in awe of the tremendous number and dedication of Nebraskans who are willing to volunteer many hours and days to serve on these boards, many with little or no pay.

New this year was the Credentialing Review Public Member Pool. The criterion for membership was formulated in partnership with the Credentialing Review Committee. Ten members were appointed to three-year terms.

The Board has an active policy in place to seek a diverse range of applicants to fill the various vacancies, taking into account such factors as ethnicity, gender, geography, and professional practice specialty, while still meeting any statutory requirements in place for representation on specific boards. Professional boards are queried as to what type of

applicants will best round out their boards, i.e., needing representation from a specific practice area, and the Board of Health strives to appoint the best applicant to meet this goal. Applicants complete an application, and those who pass a screening process by DHHS staff and Board of Health members are invited to interview before the Professional Boards Committee. They are given a preference sheet to try to accommodate their availability schedule for interview. Most of the appointments are made every year at the November meeting, several at the March meeting and others as unexpected vacancies occur throughout the year or if mandated by new legislation. The 50 appointments made after conducting 77 interviews in 2008 from the 133 applicants are listed in Attachment II. The Board could not accomplish this great task without the hard work and cooperation of staff from the Licensure Unit of the Division of Public Health. We anticipate 52 professional board appointments to be made in March and November of 2009.

In 2000, Board of Health members started actively attending the various professional board meetings, and continue to do so by attending several meetings in 2008. They appreciate the opportunity to learn how the boards function, and what if anything the Board of Health can do to aid the various professional board efforts. Board of Health members share lessons learned from their experiences at the various professional board meetings with their fellow Board members, and they consider this to be an important activity. This is particularly helpful in filling board member vacancies. This year we provided more information to applicants regarding the positions which they were applying to fill and on the Board of Health members conducting the interviews. For the fourth year a Board of Health member attended the New Professional Board Member Orientation training conducted by staff from the Division of Public Health, Licensure Unit, and presented an overview of the Board of Health's role in relationship to the professional boards.

To improve relations and communications with professional boards, the Board of Health started a new program in the fall of 2005 of inviting the chairs of professional boards to have lunch with the Board of Health members, followed by the opportunity to present their annual or executive report to the full Board of Health during the public meeting. In 2006 it evolved into an invitation to meet informally with members of the Professional Boards Committee. These meetings cannot occur during months when the Board of Health has numerous interviews and appointments to make. The Board of Health thanks:

for meeting with the Board of Health in 2008. This program assists the Board of Health members with making better appointments by understanding the issues of particular boards and their needs regarding membership composition, and helps Board members to better understand the purpose of new or revised regulations.

Information on board vacancies may be found on the Department of Health and Human Services web site. Press releases are issued, direct mailings are sent to professional and civic organizations, information is included in licensure renewal packets, and articles appear in the Health and Human Services newsletter.

#### **RULES AND REGULATIONS:**

The Board of Health has two separate roles in regard to agency rules and regulations. N.R.S. 71-2610 states the Board of Health shall advise the department regarding rules and regulations for the government of the Department of Health and Human Services, Division of Public Health. Most regulations falling into this category deal with health care facilities or with environmental issues such as well water or indoor air quality. These regulations are first reviewed by the Rules and Regulations Committee, and then are brought before the entire Board for review. Board of Health members have a diverse range of expertise, but to ensure they understand the scope and technicalities contained in these regulations, they rely on HHS staff to summarize the purpose of the proposed regulations and to attend Board of Health meetings to explain issues and answer questions. The Board appreciates the efforts of Joyce Davidson in coordinating this activity.

The Board also has the power and duty per N.R.S. 71-2610.01 to adopt and promulgate rules and regulations for the government of the professions and occupations licensed, certified, registered, or issued permits by the Department of Health and Human Services, Division of Public Health, including those rules and regulations necessary to implement laws enforced by the Division. These regulations are first reviewed by the Rules and Regulations Committee, and then voted on by the entire Board of Health.

During 2007, the Board of Health approved 17 sets of regulations, and reviewed an additional 7 sets, as listed in Attachment III.

#### **PUBLIC HEALTH AND LEGISLATIVE INITIATIVES:**

The State Board of Health has a policy in place to recognize outstanding work in community health promotion. They seek nominations from any Nebraskan who is aware of community health promotion activities across the state or entities that work directly with communities in efforts to improve and enhance their health. Nominations are accepted continually throughout the year and are reviewed by the Board of Health every other month. Award recipients receive a framed certificate and the Department of Health and Human Services issues a press release to area newspapers to announce the award. Agencies and organizations are encouraged to continue nominating worthy public health efforts for recognition. Contact Board of Health staff at 402/471-6515 for more information on this recognition program, or on any of the programs mentioned above.

Other public health and legislative activities during 2008 include:

Ongoing meetings with the Nebraska Partnership of Local Health Directors. The
Board of Health appreciates Terry Krohn, Director of Two Rivers Public Health
Department, for her presentation to the Board during their September meeting held in
Kearney. Jeff Soukup staffs the Public Health, Education and Legislation Committee,
and in September he completed a year as President of the Public Health Association
of Nebraska.

- Current public health topics under review by the Board of Health: traumatic brain
  injury as related to the use of motorcycle helmets, the benefits of water fluoridation,
  and the eight youth risk behaviors proposed by the American Medical Association as
  targets: STDs and unwanted pregnancy; Obesity; Tobacco; Alcohol; Violence;
  Accidents; Drug abuse; and Suicide. Other topics may be added based on legislation
  introduced during the current session.
- Board of Health members wrote letters for or testified at eight legislative hearings.

#### CREDENTIALING REVIEW PROGRAM:

The Credentialing Review Committee continues to discuss the process for professional reviews. They implemented changes to their report format this year, as proposed through the Nebraska Credentialing Review recommendations. They streamlined the report process and combined the previous three reports from the technical review committee, Board of Health review, and Director of the Division of Public Health into one report.

Primary activities for this committee in 2008 were completing the review of Certified Registered Nurse Anesthetists reviews, and the start of new Reviews for Gambling Assistance Counselors; Dental Assistants; and Macro Social Workers. Work was done to form a Technical Review Committee for Surgical Technologists, but no application was received.

#### **BOARD AUTHORITY:**

The Board of Health exists and functions as a result of Nebraska Revised Statutes 71-2600 through 71-2611, as revised by LB 296 in the 2007 Legislative session. The Board operates under formal by-laws, which were last revised on March 19, 2007. By-laws are available upon request, and are currently under review.

#### **COMMITTEES:**

The Board of Health has five standing committees: Professional Boards; Credentialing Review; Public Health, Education and Legislation; Rules and Regulations; and a Review Panel. Individual reports from the 2008 Committee Chairs are Attachments IV a-d of this report.

The Review Panel only conducts business on an as-needed basis, and in 2008 they did not need to meet. Three Board of Health members serve on this panel to review evidence and form recommendations to the full Board of Health. The panel becomes the prosecutors and the rest of Board of Health becomes the jurors during this process.

#### **OTHER ISSUES:**

 Upcoming meetings. Year 2009 meeting dates are: January 26 at Nebraska Bar Foundation in Lincoln; and March 16, May 18, and July 20 in Lincoln, September 21 in Columbus, and November 16 at the State Office Building in Lincoln. Professional board interviews will be conducted in Columbus on September 20<sup>th</sup> and in Lincoln on October 18<sup>th</sup>.

# Membership

In accordance with N.R.S. 71-2601, the State Board of Health consists of seventeen members in the following categories:

- Two members shall be licensed to practice medicine and surgery in this state,
- one member shall be licensed to practice dentistry in this state,
- one member shall be licensed to practice optometry in this state,
- one member shall be licensed to practice veterinary medicine in this state,
- one member shall be licensed to practice pharmacy in this state,
- two members shall be licensed to practice nursing in this state,
- one member shall be licensed to practice osteopathic medicine and surgery or as an osteopathic physician in this state,
- one member shall be licensed to practice podiatry in this state,
- one member shall be licensed to practice chiropractic in this state,
- one member shall be licensed to practice physical therapy in this state,
- one member shall be a professional engineer in this state,
- one member shall be an administrator of a hospital in this state,
- one member shall be a credentialed mental health professional, and
- two members shall be public members.

Members are appointed by the Governor with the consent of a majority of the members of the Legislature, and serve up to two five-year terms. The Governor is an ex officio member of the Board.

#### Goals for 2008 were as Follows:

- 1) Advise the full Board regarding proposals for either change in scope of practice or new credentialing,
- 2) Continue to work towards improving the efficiency and effectiveness of the Credentialing Review Program,
- 3) Screen and advise the full Board regarding members of upcoming technical review committees, and advise on which Board members would be appropriate as chairpersons, and,
- 4) Screen and advise the full Board regarding the appointment of the members of the Credentialing Review Public Member Pool.

#### Activities for 2008 were as Follows:

On January 28, 2008, the Committee members formulated advice to the full Board regarding the composition of the Credentialing Review Public Member Pool, and on the composition of the Surgical Technology Technical Review Committee. The establishment of the Public Member Pool represents the culmination of an effort by the Board to streamline the recruitment process for public members of technical review committees that function under the auspices of the Credentialing Review Program. The surgical technology issue arose as a result of the stated intention of representatives of this profession to undergo credentialing review pursuant to becoming licensed in Nebraska. Currently, surgical technologists are not regulated in Nebraska.

On May 19, 2008, the Committee members reviewed the draft fact sheet for the Public Member Pool.

On July 14, 2008, the Committee members submitted to the members of the full Board the names of persons advanced for further consideration for membership on the upcoming Macro Social Work Technical Review Committee for the full Board's review and recommendation.

Representatives of the Social Work profession have submitted a proposal for credentialing review that seeks to create a separate licensure category for macro social workers. Macro social work comprises such non-clinical services and activities of social work as advocating for vulnerable populations and organizing efforts to provide services to vulnerable populations, for example.

The Committee met via conference call on August 27, 2008 to finalize their advice regarding the composition of the Macro Social Workers Technical Review Committee.

#### Goals for 2009 are as follows:

- 1) Advise the full Board regarding proposals for either change in scope of practice or new credentialing,
- 2) Continue to work towards improving the efficiency and effectiveness of the Credentialing Review Program, and,
- 3) Screen and advise the Board regarding members of upcoming technical review committees, and advise on which Board members would be appropriate as chairpersons.

#### Activities for 2009:

The Committee members will present their recommendations to the full Board on the Gambling Counselor proposal and the Macro Social Work proposal once the respective technical committees complete their work on these proposals. The gambling counselor issue arose from efforts by Nebraska's gambling counselors to undergo a review of a proposal to license the members of their profession. Currently, gambling counselors are certified in Nebraska.

The Committee members will continue to advise the full Board regarding the appointment process for any new technical review committees and the formulation of recommendations on credentialing review proposals when they come to the Board for review.

#### Committee Duties and Responsibilities:

The Public Health, Education, and Legislation (PHEL) Committee met six times during 2008 and worked toward the following committee objective: To identify and promote public education and legislation to enhance the health, mental health, and living environment of all residents of Nebraska.

#### Committee Objectives for 2008:

- 1. Review, select, prioritize and advocate proposed legislation that enhances the health and welfare of the people of Nebraska including minority populations and those in rural environments.
- 2. Advocate and support legislative efforts to enhance opportunities for the education and development of health care professionals in Nebraska especially seeking to serve those residing in sparsely populated and remote rural environments.
- 3. Advocate, provide information, and communicate directly with state senators, DHHS committee members, and other state officials of selected legislative efforts supporting the health and mental health of residents in Nebraska.
- 4. Facilitate the Board of Health members in planning and participating in the Legislative luncheon, annual retreat, and related activities to keep all members apprised and active in the efforts of the PHEL committee.
- 5. Provide information and education of selected health programs in Nebraska that promotes public health and the prevention of health and mental health problems.
- 6. Promote cooperative efforts with health departments, public health organizations, and professional associations committed to enhancing the health and welfare of residents in Nebraska.

#### Activities in 2008:

#### January:

**LEGISLATIVE DISCUSSION.** Dr. Augustine, Chair of the Public Health, Education and Legislation Committee, listed bills of interest to his committee, as determined during a committee conference call held on January 25, 2008, and committee discussion held the morning of January 28<sup>th</sup>. Participants included Dr. Augustine, Dr. Lazure, Dr. Weber, Dr. Westerman, and staff Jeff Soukup and Monica Gissler. Dr. Augustine made a committee motion to reaffirm these positions: voting yes: all 15 (Augustine, Coleman, Discoe, Forney, Heiden, Hopp, Lazure, List, Michels, Reamer, Salansky, Sandstrom, Schafer, Weber, Westerman, Wills). Motion carried. (A supermajority of 12 was needed to pass this motion.)

#### March:

- Legislative update. Thank you letters were signed by all Board of Health members present and sent to all state senators recognizing their work on LB 395 (state smokefree worksite law)
- Dr. Michels reported on a conversation with Jeff Santema that the HHS Committee of the Legislature does not hear much from Board of Health on health issues. Dr. Michels expressed that this is a disconnect that we need to solve.
- There was discussion on the final amended language of the safe haven bill (LB 157) that was signed into law and possible consequences of the Legislation. Information was included in bill summary grid.
- Media and Education Plans / Public Health Month Update. Once the Board has reviewed and approved the health program recognition form and process the information will be widely disseminated to local health departments, departments with DHHS, Public Health Association of Nebraska, etc. in order to make them aware of this opportunity to recognize outstanding programs within their communities. The goal is to recognize at least one program per year.

#### May:

- Media and Education Plans / Public Health Month Update. Dr. Augustine discussed this with Dr. Acierno just before Dr. Schaefer had surgery, and they agreed to hold it in abeyance until after she returns.
- LB 245 Fluoridation. Dr. Westerman discussed that the Board of Health did support this bill and it did pass after an override of the Governor's veto. \$1.2M is anticipated to get communities up to speed for education and the Nebraska Dental Association will do whatever they can to help this transpire. It could be community money, federal money, etc. This would be a lot easier to achieve if we had a State Dental Director.
- Recognition to public health programs and individuals. Will try to become more active as a committee and will keep updated.

#### July:

• Fluoridation support letters – there is concern regarding the amount of controversy related to fluoridation – need to supply letters/statements of support to communities. We encourage the Nebraska Dental Association to strongly support this in their communities. Jeff Soukup will follow up with a letter to the NDA.

#### September:

There was an update by Jeff Soukup on the smoke-free worksite law (LB395) implementation. Information is available at <a href="www.smokefree.ne.gov">www.smokefree.ne.gov</a>. The public hearing on the Clean Indoor Act was held on September 25<sup>th</sup>.

- There was committee discussion about sending a letter to the editors of community newspapers across the state about LB 245, the water fluoridation bill. Specifically, there is concern about the opt-out provision language on ballots being clearly written and easily understandable by the public. Jeff and Monica will draft a letter.
- Public Health Recognition Program all were in favor by voice vote to resurrect this program. Letters will be sent to the local health directors, with a possible tie in to PHAN (Public Health Association of Nebraska).
- Possible retreat for January 25<sup>h</sup>. The PHEL Committee will develop the draft agenda at their November meeting.
- The PHEL conference call to review legislation introduced will be on Friday, January 23, 2009.

#### **November**

- Legislative Update Fluoridation 61 communities had the option to "opt out" on their November ballot, and 49 communities did that. We congratulate the 12 communities who stepped up to the plate and voted for fluoridation.
- Legislative Luncheon January 26, 2009 some plans to combine issues to help the new senators, including a brief explanation of the 407 process and board appointment process. There will be a PHEL Committee conference call on January 23<sup>rd</sup> to review the priority legislative bills, starting at noon on that Friday.
