Foster Care: The Basics

- 1. Authorized Representatives One or both foster parents, even when only one parent is listed on the placement papers
- 2. Proof of ID & Residency..... Placement papers
- 3. Proof of Income ... Adjunct Eligible/always get Medicaid, verbal \$ from State
- 4. Family Size... 1 (one)

Foster Care: Placement

- 1. **Kinship** Foster parent(s) are someone related to the child(ren), or someone the child(ren) have an existing relationship with. Usually the only foster children in the home.
- 2. Non Kinship.... Foster parent(s) are unknown to the child(ren). May or may not have other foster children in the home.

Foster Care: Retrieving From Bio Family

1. Kinship Placement (relative):

- Child(ren) are the only active WIC participants
- Other Bio family members are active WIC participants

- If it is a "Kinship" placement expected to be longterm, may use 2 month issuance
- 3 month issuance is not used for foster children





- Void checks using "Foster Change"
- Void current month and future months
- Current month subject to proration
- Don't have to wait to get the checks back
- Follow-up with previous Authorized Rep? Letter, don't use checks
- Checks will show on the report if voided and redeemed

Change in Foster Placement – Check Questions from LAs

-) Should we always ask that checks be brought back to clinic so we can reissue? How are other clinics doing this? (finding that new authorized rep has already signed the checks and in some cases used the checks before coming into clinic and letting them know about the change in placement)
- 2) Should they reprint the checks with the new family ID number on them or continue to pass the original checks on to the new family?





Foster Parent has no paperwork

- It is the foster families responsibility to provide paperwork
- Name on placement papers does not match the foster child being enrolled/transferred

Bio Mom has visitation ... wants WIC for child

- Only Foster Parents can receive WIC for foster children
- Foster parents should be sharing WIC foods/formula with Bio mom
- If they do not, contact caseworker

Child moves to another foster home – Proof required?

• Foster family should have placement papers

Child moves back to Bio Family – Proof required?

- Written or verbal verification from caseworker

Bio Mom getting WIC --

- For child/infant who is in foster care (dual/fraud/sanction)
 - ✓ Call mom
 - ✓ Ask her to return unused checks to clinic (mail or in person)
 - ✓ Fill out Integrity Screening Form and scan into record
 - ✓ Notify State Clinic Services Coordinator
 - Name
 - ✓ Family Number
 - ✓ Summary of situation
 - ✓ Do not use anymore checks....they are considered stolen
 - ✓ When unable to reach mom, send letter

Foster Family will not share WIC formula/food for visitation --

- Have Bio mom notify caseworker
 - ✓ Call mom
 - ✓ Ask her to return unused checks to clinic (mail or in person)
 - ✓ Fill out Integrity Screening Form and scan into record
 - ✓ Notify State Clinic Services Coordinator
 - ✓ Name
 - ✓ Family Number
 - ✓ Summary of situation

 - ✓ When unable to reach mom, send letter

Bio Family/Foster Family will not Give WIC Checks to New Family when Placement Changes --

- ✓ Call family
- ✓ Ask them to return unused checks to clinic (mail or in person)
- ✓ Fill out Integrity Screening Form and scan into record
- ✓ Notify State Clinic Services Coordinator
 - ✓ Name
 - ✓ Family Number
 - ✓ Summary of situation
- ✓ Do not use anymore checks....they are considered stolen
- ✓ When unable to reach family, send letter
- ✓ Have family notify caseworker

Foster Care Questions

- What information can we share with case managers and can they share with us?
 - The same information you would share with a parent/authorized rep.
- Who should we provide nutrition education to when bio mom has visitation?
- Bio mom brings child to be weighed and measured...is that ok?

Foster Care Questions

- Why are DHHS contractors wanting to come to WIC now and enroll children in place of foster parents?
 - Foster parents should be the ones coming to visits/enrolling children
 - Exceptions are when foster parent cannot due to emergency

DUPLICATE RECORDS

Duplicate Records

1. Always use Person's ID when typing in Names!

2. Use Upper & Lower Case letters when entering names!

3. Use the Wildcard %%%% when searching!




Duplicate Records



- Do Not use hyphens in Names
- Only use middle initials when two people in the same family have identical first and last names.
- Take your time
- Search using the Wildcard
