

SECOND AMENDMENT

This document (hereinafter, the Amendment), amends the service contract **Family Support & Visitation Only #7219** (hereinafter, the Contract) entered into on July 1, 2006, by and between the Department of Health & Human Services (hereinafter, the Department) and **Avenues to New Horizons** (hereinafter, the Contractor).

WHEREAS, the original term of the Contract was from July 1, 2006, through June 30, 2008.

WHEREAS, the parties herein seek to remove reference to Employment First in the Contract ending June 30, 2008.

WHEREAS, the continued performance of the Contractor, here under, does not require an adjustment to the Contract budget.

NOW, THEREFORE, the parties agree as follows:

Section 1. General Provisions

- 1.1 This Amendment becomes effective only upon the signing of all parties hereto.
- 1.2 The Recitals set forth above are an integral part of this Amendment; therefore, they are hereby incorporated herein.
- 1.3 The written Contract, all attachments, any prior amendments, and this Amendment represent the entire agreement between the parties, and any prior or contemporaneous representations, promises, or statements by the parties, that are not incorporated herein, shall not serve to vary or contradict the terms set forth in the written agreement between the parties.

Section 2. Amended Terms

- 2.1 Article II of the Contract is amended by deleting the first sentence and replace it with the following: "The Contractor agrees to provide Family Support and Visitation Only Services for families of state wards and voluntary CFS cases upon referral by the Department or by a Behavioral Health Region (ICCU) contracted with the Department to provide case management services for state wards.
- 2.2 Article II.A.1. is amended by deleting the last sentence of subsection 1.
- 2.3 Article II A.7.a. is amended by deleting "or the Employment First Case Manager" from the first sentence.
- 2.4 Article II.A.7.b. is amended by deleting "Employment First Case Manager or" from the second sentence.
- 2.5 Article II.B.2.a. is amended by deleting "Employment First Case Manager or" from the first sentence.
- 2.6 Article III.H. is amended by deleting "Employment First case Manager or" from the first sentence.
- 2.7 All other terms and conditions of said Contract, and the addendum referenced herein, not hereinafter modified or amended, shall remain in full force and effect.
