<u>AMENDMENTS</u>: If the name of the pharmacy changes or if there is a new pharmacist-in-charge, the pharmacy must submit an Application for Amendment. You may indicate changes on this form, but they will not appear on the renewed license unless an Application for Amendment has been processed. You may obtain the Application for Amendment online at website listed below. You do <u>not</u> have to wait until the license has been amended in order to submit your renewal.

<u>CHANGE OF OWNERSHIP OR ADDRESS</u> – A pharmacy license is issued only for the premises and owners named in the application. It is not transferable. Change of ownership (sale, whether of stock, title, or assets, lease, discontinuance of operations) or change of premises terminates the license. You must apply for a new pharmacy license. You may obtain the new application and closing information at the website listed below.

<u>CLOSINGS</u> – When a pharmacy ceases legal existence, changes location, or has a change of ownership, the pharmacist-in-charge must notify the Department within 15 days of closing. You can find the regulations that cover the closing of a pharmacy in 175 NAC 8 Section 8-003.04. You may obtain the closing information online at the web site listed below.
