VACANCY

The Department of Health and Human Services is now accepting applications for the following positions on this board. Full terms are for December 1, 2025-November 30, 2030.

- Electrologist Member – partial term through November 30, 2029
- Tanning Salon Owner Member – partial term through November 30, 2029
- Nail Technician Instructor or Esthetics Instructor Member – partial term through November 30, 2029
- Esthetician Member – partial term through November 30, 2027
- Body Artist
- Cosmetologist – partial term through November 30, 2028
- Public Member

NOTE: No members of the board who are school owners, salon owners, electrologists, nail technicians, instructors, cosmetologists, or practitioners of body art may be affiliated with the same establishment. The cosmetologists, nail technician, esthetician, and instructors on the board SHALL NOT own a School of Cosmetology, Esthetics, or Nail Technology.

APPLICATION AND SUPPORTING DOCUMENTS

The following documents must be submitted to apply for the positions listed above:

- Completed [Cosmetology Board](#) or [Public Member](#) application and resume or curriculum vitae recommended if available
- Letters of recommendation: If applicant chooses to submit letters of support or recommendation, they may be submitted directly to Board of Health staff at the address listed on the application or via email. **All documentation must be received by August 1, 2025.**

PERSONAL INTERVIEWS

The Professional Boards Committee of the Board of Health will meet in Lincoln on Sunday afternoon, September 14, 2025 to conduct interviews with applicants, and formulate recommendations for board appointments. If you have a conflict with this date, please contact Board of Health staff to discuss it. Interviews will be held via telephone or in person.

These personal interviews last approximately 10 minutes and will be scheduled to provide applicants the opportunity to inform the Professional Boards Committee of their goals and

desires for serving on the board and to respond to questions presented by members of the Committee. After application, you will be notified if you are selected for an interview.

APPOINTMENTS AND NOTIFICATION OF APPOINTMENTS

The Professional Boards Committee recommendations for appointments will be submitted to all Board of Health members and appointments will be made at the Board of Health meeting scheduled for the afternoon of **September 15, 2025**.

Board of Health staff will notify applicants after the Board of Health meeting as to whether they were appointed to the Board of Cosmetology, Electrology, Esthetics, Nail Technology, and Body Art.
