Your renewal application and fee (if applicable) must be POSTMARKED ON OR BEFORE 11/01/2019 to avoid expiration of your license.

Online License Renewal: You may renew your license online at <https://nebraska.mylicense.com/>. To register online you will need your license number, your social security number and a credit or debit card with a MasterCard or Visa logo.

Failure to Submit Renewal by Expiration Date: If you fail to submit a completed renewal by the expiration date, your license expires. To practice after this date, your license must be reinstated. **If you practice without an active license**, an administrative penalty of \$10 per day up to \$1,000 will be assessed for each day of practice.

Military service is defined as full-time duty in the active military of the United States, a National Guard call to active service for more than 30 consecutive days, or active service as a commissioned officer of the Public Health Service or the National Oceanic and Atmospheric Administration. I understand that I may be required to submit a copy of my military orders to the DHHS Licensure Unit. There is no fee or continuing education requirement for military status.

Continuing Education (Select ONLY One):

 3. An explanation of each conviction, including what happened (what, when, where, why), and a summary of what action you have taken to address the behavior that caused each conviction;
 4. All addiction/mental health evaluations and proof of treatment, if the conviction involved drugs or alcohol and if treatment was received/required; and
 5. A letter from your probation office addressing conditions and current status, if you are currently on probation.
- NOTE:** ALL misdemeanor convictions and felony convictions must be reported within 30 days of the conviction/action. Failure to report may result in disciplinary action against your Nebraska license.

Citizenship/Lawful Presence (Select ONLY One):
