#### **DEPARTMENT OF AGRICULTURE UPDATES**

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department was present for discussion with the Board.

NPAI (Highly Pathogenic Avian Influenza) has been reported in virtually all the surrounding states to Nebraska in significant numbers. Fortunately, there have only been two backyard flocks with NPAI reported and investigated in Nebraska to date.

Dr. Fritts is currently in the process of hiring market Veterinarians to fill vacancies at some of the livestock markets in Nebraska. There are 38 livestock markets located throughout Nebraska.

Several Emergency Preparedness exercises are being planned throughout the year.

#### **2024 LEGISLATION UPDATES**

Jessika Benes, DVM, Juniata, NE and NEVMA Board of Directors member was present to discuss the 2024 Legislation Bills that have been introduced that the NEVMA will be following and may be of interest to the Board:

<u>LB16</u> - Require occupational boards to issue certain credentials based on credentials or work experience in another jurisdiction and make a determination regarding an applicant with a criminal conviction, provide for jurisprudential examinations and appeals from denial of a license, and change requirements for membership of the State Electrical Board.

NEVMA is concerned that work experience alone is not enough qualification for licensure in Nebraska based on comparison of other states requirement qualifications, especially for Veterinary Technicians.

#### **REGULATION UPDATES**

The Board continued the discussion regarding the need for Veterinary Technicians especially in the field of large animal veterinary practices and the possibility of amending the scope of practice to include additional procedures for Veterinary Technicians in the Nebraska Veterinary Medicine and Surgery Regulations, Title 172 Chapter 180.

Survey questions from the Board have been finalized. Megan Kilgore, Executive Director of the Nebraska Veterinary Medical Association (NEVMA) was present at the meeting and has agreed to email the survey questions to the NEVMA constituents and all Nebraska licensed Veterinarians and licensed Veterinary Technicians to solicit their feedback responses.

Be sure to send in your response to the survey. The Board is very interested in receiving the feedback so that they can make an informed recommendation for amending the Regulations to best accommodate the needs of the Nebraska veterinary community.

The Board and the Department want to extend our appreciation to Megan and the NEVMA for assisting in the assimilation and distribution of this survey.

Tim Sobotka, DVM, Spencer, NE brought up the question of creating a "Mid-Level" position to ease some of the pressures of the rural Veterinarian for procedures such as pregnancy tests, processing calves, dehorning and fertility testing of bulls. Farrington explained that expanding the scope of practice for Veterinary Technicians to include those types of procedures under a level of Veterinarian supervision may be a more direct route rather than adding another level of a licensed credential. Adding another level of a licensed credential would involve legislative changes and establishing license testing protocols, etc. Josh Schlote is an instructor at the Northeast Veterinary College in Norfolk, and he indicated that all the above procedures that Dr. Sobotka mentioned are currently being taught at the college, however because of the restraints of the current Nebraska Regulations by law the Veterinary Technician cannot practice those procedures under any of the Veterinarian supervision levels.

Barrett Huneke, DVM, St. Paul, NE also brought up another procedure of concern, necropsy. Can the Veterinary Technician under certain supervision take samples with the Veterinarian making the diagnosis.

Lisa Redington, LVT, Omaha, NE mentioned that back in the day when she attended school, they were offered instruction in artificial insemination in bulls.

It was a good open discussion exploring many options for expanding the scope of practice for the licensed Veterinary Technician with supervision. Remember the Board absolutely needs the feedback from the veterinary community to be able to make the best possible recommendations for advancing the Regulations.

A. Can Veterinary Technicians collect embryos in cattle? Can Veterinary Technicians implant embryos in cattle?

It is the opinion of the Board that collection of embryos and implantation of embryos in cattle would be considered to be surgery. Surgery is reserved for the Veterinarian.

<u>004.04 TASKS RESERVED FOR A VETERINARIAN</u>. Licensed veterinary technicians or unlicensed veterinary assistants are not permitted to do any of the following:

- (A) Make a diagnosis or prognosis;
- (B) Prescribe any treatment, drugs, medications or appliances;
- (C) Perform surgery; or
- (D) Administer rabies vaccine.
