#### **6. 172 NAC 162 PROMULGATION UPDATE**

Covert-ByBee stated the regulations are currently with the Attorney General's office being reviewed for constitutionality.

#### **7. LEGISLATIVE UPDATE**

Covert-ByBee stated the Legislature has closed due to the COVID-19 pandemic and will remain closed until the speaker deems it fit for them to reconvene. She continued that on January 1, 2020 the legislation approving fee waivers for young workers, military and military family and low income applicants as defined by the bill for initial license applications went into effect.

Covert-ByBee advised that an executive order signed by the Governor on March 27<sup>th</sup>, 2020 modified some of the statutes and regulations. It waives licensure requirements for individuals licensed in other states and in good standing allowing them to come into Nebraska and work immediately during this emergency declaration. Renewal has also been suspended for certain professions during the emergency declaration.

#### **8. LICENSURE APPLICATION PROCESSING REPORT**

Carranza presented the Licensure Application Processing Report, it was for informational purposes only.

#### **9. PUBLIC COMMENT**

There were no comments.

#### **10. TOPICS FOR NEXT MEETING**
