

## Minutes of the October 29, 2019 Board of Physical Therapy Meeting

### **1. ROLL CALL**

Rachel Reiman, Chairperson, called the meeting of the Board of Physical Therapy to order at 1:17 p.m. on Tuesday, October 29, 2019 in Conference Room C at Cornhusker State Industries, 800 Pioneers Boulevard, Lincoln, Nebraska. The meeting was duly publicized by distribution of the Notice of Meeting and Agenda at least ten (10) days prior to the meeting and posting the agenda at the entrance of the Department of Health and Human Services Division of Public Health at least twenty-four (24) hours prior to the meeting.

### **4. DISCUSSION/RESPONSE TO COMMENTS FROM PUBLIC HEARING**

Covert-ByBee stated that all comments at the meeting were positive and supportive of the recommended changes to the regulations. Since all of the comments were positive, there is no need for a board response. Additionally she outlined the next steps in the process. The revisions will be submitted to the Board of Health for review and approval, then to the Chief Medical Officer/Director of Public Health Dr. Gary Anthone. After that they will go to the Attorney General's Office to review for constitutionality and then to the Governor's Office for final approval. Once approved by the Governor's Office, they will be filed with the Secretary of State's office and become official five days after filing. At any point during the review process if issues are identified they can be sent back to the department and restart the process.
