

Summary of the School Immunization Rules and Regulations 2010-2011

Student Age Group	Required Vaccines
2-through 5 years of age enrolled in a school based program not licensed as a child care provider	<p>4 doses of DTaP, DTP, or DT vaccine,</p> <p>3 doses of Polio vaccine,</p> <p>3 doses of Hib vaccine or 1 dose of Hib given at or after 15 months of age,</p> <p>3 doses of pediatric Hepatitis B vaccine,</p> <p>1 dose of MMR or MMRV given on or after 12 months of age,</p> <p>1 dose of varicella (chickenpox) or MMRV given on or after 12 months of age. written documentation (including year) of varicella disease from parent, guardian, or health care provider will be accepted.</p> <p>4 doses of pneumococcal disease or 1 dose of pneumococcal given on or after 15 months of age</p>
Students entering school for the first time (K or 1 st Grade)	<p>3 doses of DTaP, DTP, DT, or Td vaccine, one given on or after the 4th birthday,</p> <p>3 doses of Polio vaccine,</p> <p>3 doses of pediatric Hepatitis B vaccine or 2 doses of adolescent vaccine if student is 11-15 years of age.</p>
Students entering 7 th Grade	<p>2 doses of MMR or MMRV vaccine, given on or after 12 months of age and separated by at least one month,</p>
Transfer students from outside the State of Nebraska, regardless of grade (includes any foreign students)	<p>For 7th Grade Only – 1 dose of Tdap (must contain Pertussis booster) – this dose can be received any time after 10 or 11 years of age depending on which brand of vaccine is received.</p> <p>1 dose of varicella (chickenpox) or MMRV if given on or after 12 months of age and prior to 13 years of age. If given at over 13 years of age, 2 doses of varicella (no MMRV), separated by at least one month. Written documentation (including year) of varicella disease from parent, guardian, or health care provider will be accepted.</p>
All students not listed above (grades 1 through 6 and 8 through 12)	<p>3 doses of DTaP, DTP, DT, or Td vaccine, one given on or after the 4th birthday,</p> <p>3 doses of polio vaccine</p> <p>3 doses of pediatric Hepatitis B vaccine or 2 doses of adolescent vaccine if student is 11-15 years of age</p> <p>2 doses of MMR or MMRV vaccine, given on or after 12 months of age and separated by at least one month,</p> <p>1 dose of varicella (chickenpox) or MMRV if given on or after 12 months of age and prior to 13 years of age. If given at over 13 years of age, 2 doses of varicella (no MMRV), separated by at least one month. Written documentation (including year) of varicella disease from parent, guardian, or health care provider will be accepted.</p>
