IMMUNIZATION CLINIC DIRECTORY

This Immunization Directory includes all the public immunization clinics in Nebraska. These clinics immunize healthy children up through the age of 18. They are operated on a limited basis by a number of agencies including; hospitals, health departments, home health agencies, community action agencies, etc. Each immunization clinic is listed in the directory by location and includes the days and times they operate. Most of them request that you make an appointment but they will try to accommodate walk-in clients. All of the public immunization clinics are enrolled in the Vaccines for Children Program. Donations are usually requested, but no one will be denied immunizations for inability to contribute.

This directory does not list private physicians' offices and clinics. You will need to contact your physician directly to see if he or she is enrolled in the Vaccines for Children Program.



WIC PROGRAM

WIC clinics that are held in conjunction with Immunization Clinics (same time, same place) have been listed in this directory, and are so indicated with *asterisks*.

The Special Supplemental Nutrition Program for Women, Infants and Children (WIC) is a program for pregnant, breastfeeding and postpartum women, infants, and children up to the age of five who are at nutritional risk. WIC provides nutrition and breast feeding information, extra foods, and referrals to other health programs, community services and agencies.

You may call the Pender office at 402-385-6300 to obtain the proper forms. There is suggested donation of \$13.50 for a single vaccination, or a suggested donation of \$20.00 per visit. No one will be denied vaccinations for inability to pay.

Immunization records are required at each clinic visit.

It is important to follow up with your family physician for well-baby or childhood checkups on a regular schedule.
