

PHASE II

WHAT IS IT?

1. Automated E-mails

- Email notifying you the Certifier has completed the record
- Rejected & Queried Records
- When records haven't been completed within 14 days after death & certifier has signed the record
- Record has been accepted & certified copies can be issued

2. Fax Attestation

FAX ATTESTATION



What is it ?

And

How do I do it?

Simply Put

- It's a way for the certifier to complete the record manually
- Someone other than the certifier enters the information electronically & prints an attestation form
- The attestation attaches to record when faxed



How do I begin?

Always begin by entering "E"




