Inspecting the Radon Mitigation System During Home Inspection will be conducted by MURC-Kansas State University in the morning from 8am to 12noon, 4 hours

This course provides information about properly installed radon mitigation systems, along with an overview of radon, radon entry and behavior, standard radon mitigation methods, available system checklists from national programs and regulatory states, and lots of examples of what, and what not to do!

Fighting the Radon Wars: New Marketing Tools to Add to Your Arsenal will be conducted from 1-5 pm by Spruce Environmental Technologies, Inc. 4 hours

Join other radon warriors to explore the research on how, why and where people purchase. Topics include successful risk communication and the new field of neuro-economics. Brush up on your Internet and social media skills to encourage more radon testing and fixing.
