

# **PUBLIC IMMUNIZATION CLINIC DIRECTORY**

This directory includes all the public immunization clinics in Nebraska. These clinics immunize healthy patients that are eligible to receive services. Each immunization clinic is listed in the directory by location and includes Agency contact information. Clients should call to verify address/dates/hours of operation and to determine if an appointment is necessary. Donations or an administration fee might be requested, but no one will be denied immunizations for inability to pay.

This directory does not list private physicians' offices and clinics. You will need to contact your physician directly to see if he or she is participating in the NDHHS Immunization programs.

## **Public Clinics in Nebraska**

For the purposes of the NDHHS Immunization Program, a public clinic is a clinic operated by a public or non-profit agency, such as a county or district health department, tribal health facility, community action agency, or home health/hospital-sponsored clinic. A public clinic meets the needs of the community that are not already met by other providers, so in a large way serves as a "safety net" for those populations. In addition, the public clinic follows the below operating guidelines:

- Has the capacity to serve all eligible children through 18 years of age, with the possibility of serving eligible adult patients as well
- Serves healthy clients without contraindications
- Has a sponsoring physician, who can be off-site during clinic operation
- Offers all ACIP recommended vaccines, with the exception of those intended for use with high-risk patients
- Accommodates walk-in patients, although can ask patients to make an appointment
- Any funds generated are used to support immunization clinic functions

## **Vaccines for Children Program**

The Vaccines for Children (VFC) program provides all recommended vaccines to children who are eligible. Who is eligible for Vaccine for Children (VFC) Vaccine?

- Children birth through 18 years of age AND one of the following:
- American Indian or Alaska Native
- Medicaid enrolled
- Uninsured (have no health insurance)
- Underinsured (see below for definition of underinsured)

## **Adult Immunization Program**

The Adult Immunization Program (AIP) provides most recommended vaccines to adults who are eligible. This program is limited, and not all VFC providers are AIP providers as well. Who is eligible for Adult Vaccine?

- Age 19 and older
- Uninsured (have no health insurance)
- Underinsured (see below for definition of underinsured)

## **Underinsured Status**

One eligibility category for publicly funded vaccines is having underinsured status. Underinsured patients would be those who:

- have commercial (private) health insurance but the coverage does not include vaccines
- have insurance that covers only selected vaccines (VFC/AIP eligible only for vaccines that are not covered)
- have an insurance plan that caps vaccine coverage at a certain amount (once that coverage amount is reached the patient is categorized as underinsured)

Having a high-deductible plans – those with a large cost to the patient before a benefit begins – are not considered underinsured.

Underinsured patients can only be seen in Federally Qualified Health Centers (FQHCs), Rural Health Clinics (RHCs), or Deputized clinics. All public clinics in Nebraska are deputized to serve underinsured patients.
