

Nebraska Ultrasound Providers (Neb. Rev. Stat. 28-327.01)

(Updated November 2013)

As directed by Neb. Rev. Stat. 28-327.01(1), the Department of Health and Human Services shall cause to be published the following easily comprehensible materials (c) a comprehensive list of health care providers, facilities, and clinics that offer to have ultrasounds performed by a person at least as qualified as a registered nurse licensed under the Uniform Credentialing Act, including and specifying those that offer to perform such ultrasounds free of charge. The list shall be arranged geographically, and shall include the name, address, hours of operation, and telephone number of each entity.
