Setting	<p>SUD assessment addendum for adults can be provided in any of the following settings:</p> <ul style="list-style-type: none"> • Clinic • Office • Home • Community setting that is appropriate for the provision of this service
Licensure, Certification, or Accreditation	<p>If this service is provided by a Mental Health Substance Abuse Treatment Center, they must be licensed and accredited by CARF, TJC, or COA, and accredited to provide the level of care applicable to this service as required by DHHS Division of Medicaid and Long-Term Care (MLTC)</p> <p>If this service is provided by a hospital, the hospital must be licensed and accredited by TJC or AoA and must be accredited to provide the level of care applicable to this service as required by DHHS Division of Medicaid and Long-Term Care (MLTC)</p> <p>Individual providers must be licensed as required by DHHS Division of Medicaid and Long-Term Care (MLTC)</p>
Basic Definition	<p>The purpose of the addendum is to clarify/update the diagnosis, treatment needs and recommendations and/or gather information that covers the time frame when an individual was not receiving treatment. It must be conducted in accordance with the American Society of Addiction Medicine (ASAM) guidelines</p>
<p>Service Expectations</p> <p>(Information about this service is referenced in Title 471 chapter 20)</p>	<ul style="list-style-type: none"> • An SUD assessment addendum is necessary when the most recent SUD assessment was performed more than 12 months ago or when the SUD assessment needs to be updated with new information or when there is a change in clinical status • If the individual leaves treatment prior to a successful discharge and fails to return within six months, the provider must assess whether a new SUD assessment needs to be completed or if an SUD assessment addendum is adequate • The need for updated information is to be reflective of the individual’s current status, any changes in substance use patterns, functioning, and treatment goals • The addendum must reflect information that has not been addressed in the clinical notes and capture information that covers the period of time outside of treatment • All individuals are to be screened for co-occurring mental health conditions throughout the SUD assessment addendum. If the staff performing the SUD assessment addendum is a licensed alcohol and drug counselor (LADC) or a provisionally licensed alcohol and drug counselor (PLADC), and a co-occurring mental health condition is known or suspected, a referral must be made to a licensed clinician who is able

	<p>to diagnose and treat mental health conditions within their scope of practice and license</p> <ul style="list-style-type: none"> • Medicaid will provide reimbursement for one substance use disorder addendum annually, if medically necessary, including a change in diagnosis • Provide access to Medication Assisted Treatment (MAT) as medically appropriate • All services must be provided with cultural competence

Desired Individual Outcome	Upon completion of the substance use disorder assessment addendum, the individual will have been assessed for a substance use disorder diagnosis, an assessment of risk of dangerousness to self or others, or both, and recommendation for treatment, recovery, and rehabilitation planning with the appropriate service level and referrals to appropriate service providers
