Division of Children and Family Services Child Care Subsidy Provider Approved Pediatric First Aid/CPR Courses

Intended Audience: Child Care Subsidy Provider

All Child Care Subsidy providers and staff who work with children are **required** to complete <u>pediatric</u> first aid and cardiopulmonary resuscitation training and maintain certification during their enrollment period.

Below is a list of approved training providers and/or courses for Child Care Subsidy providers to reference. This is not comprehensive and there may be other training providers/course that are accepted or denied. Please remember that all pediatric first aid/CPR training course <u>must</u> contain an in-person skills demonstration to be accepted. Course description and/or proof of pediatric and skills demonstration may be requested.

Any training that is ONLINE ONLY, will **not** be accepted.

If you are unsure if the course you are interested in will be accepted, please reach out to your assigned Resource Developer prior to booking/paying for the course.

Key things to look for when choosing your course:

- Does the course cover child and infant first aid/CPR? (May be worded as child and infant/baby or pediatric)
- ✓ Does the course cover both CPR and first aid?
- ✓ Is there an in-person skills demonstration? (May be described as "testing out" or "instructorled" session)

***The Department may request a course description and/or proof of pediatric component and inperson skills component if there is reason to believe either requirement was not met.

Did you know?

Child Care Centers enrolled in Child Care Subsidy may submit a request for reimbursement⁺ for up to 50% of the cost of pediatric first aid/CPR training within 90 days of completion of the course for their employees. To request reimbursement, Center directors should complete the reimbursement request form for all staff who participated in training and attach or scan their certification cards or certificates and all <u>paid</u> receipts from their training(s) to the form. The form, certificates, and receipt(s) are then submitted to Child Care Subsidy at <u>dhhs.ccsubsidy@nebraska.gov</u>, by mail, or through the assigned Resource Developer. The Center will receive reimbursement through Subsidy billing.
