Child and Family Services Reviews

- Collaborative effort between federal and state governments
- Promote continuous quality improvement in child welfare systems nationally
- Evaluate state performance relative to federal requirements and state Child and Family Services Plan
- Identify both the strengths and areas needing improvement in state child welfare programs

Child and Family Services Reviews

- States that do not meet initial standards develop an action-oriented 2-year Program Improvement Plan
- The Children's Bureau works to assist states in enhancing their capacity to help children and families achieve positive outcomes through ongoing technical assistance support



CFSR Process

 Child welfare outcomes assessed using information collected through case review



CFSR Outcomes

- Two Safety Outcomes
- Two Permanency Outcomes
- Three Well-Being Outcomes



CFSR Case Review

- 65 cases were reviewed using the federal Onsite Review Instrument (OSRI)
 - 25 in-home cases
 - 40 foster care cases
- Cases reviewed in three sites:
 - Douglas County
 - Hall County
 - Platte/Colfax Counties



CFSR Process

Systemic functioning assessed using:

- Statewide assessment
- Interviews with key stakeholders



CFSR Systemic Factors

- Statewide Information System
- Case Review System
- Quality Assurance System
- Staff and Provider Training
- Service Array and Resource Development
- Agency Responsiveness to the Community
- Foster and Adoptive Parent Licensing, Recruitment, and Retention



CFSR National Measures

The state's performance is considered relative to the following National Measures:

- Recurrence of maltreatment
- Maltreatment in foster care
- Permanency in 12 months for children entering care
- Permanency for children in care 12-23 months
- Permanency for children in care 24+ months
- Re-entry into foster care in 12 months
- Placement stability




Preliminary Case Review Findings

- Outcome Ratings
- Themes
 - Strengths
 - Areas Needing Improvement



Practice Strengths

- Services were provided in voluntary inhome cases even when allegations were unsubstantiated
- Good use of relative placements which also enhanced placement stability
- Timely establishment of initial case plan goals



Practice Strengths

- Children were maintained in their schools, community, extra-curricular activities when placed in foster care
- Frequent visitation between mothers, fathers, and siblings
- Even in complex cases, services were individualized
- Very strong engagement of parents and children with case workers

Areas Needing Focus

- Delay of face-to-face contact during investigations
- Quality of initial and ongoing assessment
- Court challenges resulted in delays in permanency
- Involvement and assessment of noncustodial parents and paramours
- Assessment and service provision to formal forma

Safety Outcome 1

Children are, first and foremost, protected from abuse and neglect.

71% Safety Outcome 1

OSRI Item 1: Timeliness of Initiating Investigations of Reports of Child Maltreatment

71% of 21 cases rated as a Strength



Safety Outcome 2

Children are safely maintained in their homes whenever possible and appropriate.

58% Safety Outcome 2

OSRI Item 2: Services to Family to Protect Child(ren) in the Home and Prevent Removal or Re-Entry Into Foster Care

82% of 17 cases rated as a Strength

OSRI Item 3: Risk Assessment and Safety Management

58% of 33 cases rated as a Strength



Permanency Outcome 1

Children have safety and stability in their living situations.

40% Permanency Outcome 1

OSRI Item 4: Stability of Foster Care Placement

75% of 20 cases rated as a Strength

OSRI Item 5: Permanency Goal for Child

65% of 20 cases rated as a Strength

OSRI Item 6: Achieving Reunification, Guardianship, Adoption, or Other Planned Permanent Living Arrangement

45% of 20 cases rated as a Strength



Permanency Outcome 2

The continuity of family relationships and connections is preserved for children.

70% Permanency Outcome 2

OSRI Item 7: Placement With Siblings

81% of 16 cases rated as a Strength

OSRI Item 8: Visiting With Parents and Siblings in Foster Care

71% of 17 cases rated as a Strength



Permanency Outcome 2 Cont.

OSRI Item 9: Preserving Connections

80% of 20 cases rated as a Strength

OSRI Item 10: Relative Placement

90% of 20 cases rated as a Strength

OSRI Item 11: Relationship of Child in Care With Parents

64% of 14 cases rated as a Strength



Well-Being Outcome 1

Families have enhanced capacity to provide for their children's needs.

45% Well-Being Outcome 1

OSRI Item 12: Needs and Services of Child, Parents, and Foster Parents

48% of 33 cases rated as a Strength

OSRI Item 12A: 79% of 33 cases rated as a Strength

OSRI Item 12B: 52% of 29 cases rated as a Strength

OSRI Item 12C: 65% of 20 cases rated as a Strength

OSRI Item 13: Child and Family Involvement in Case Planning

63% of 32 cases rated as a Strength

Well-Being Outcome 1 Cont.

OSRI Item 14: Caseworker Visits With Child

82% of 33 cases rated as a Strength

OSRI Item 15: Caseworker Visits With Parents

52% of 29 cases rated as a Strength



Well-Being Outcome 2

Children receive appropriate services to meet their educational needs

82% Well-Being Outcome 2

OSRI Item 16: Educational Needs of the Child

82% of 22 cases rated as a Strength



Well-Being Outcome 3

Children receive adequate services to meet their physical and mental health needs

55% Well-Being Outcome 3

OSRI Item 17: Physical Health of the Child

79% of 24 cases rated as a Strength

OSRI Item 18: Mental/Behavioral Health of the Child

59% of 22 cases rated as a Strength
