- a) DD Council Person Centered Planning Sub-award
  - o DD Council just approved \$108,000 in subaward funding to develop and distribute Person-Centered Planning training in Nebraska. The Council is collaborating with DHHS Division of Medicaid and Long Term Care (MLTC) to provide funding for this project. Funds from Medicaid's Money Follows the Person program in the amount of

\$78,000 will be utilized with \$30,000 in Council funds for this one year project that begins October 1, 2019.
