- **Mike Brown** Appreciate being invited to meeting.
- Edison McDonald A couple of things, interested in the new process. Not fully complement with open meeting. This is much more how the board should be operating than what I have seen. Great pieces in the letter. Wanted to address issues with child day habilitation – lots of conversation, first five, and Lincoln littles are running a child care IDD task force looking at overlapping issues, trying to figure out how to bring this along. Trying to think how FSW will be provided under DD agencies and independent providers, but we need to figure how child care agencies can participate. Hastings – trying to figure out how they can provide services. Consider a much abbreviated application/process is included and not expanded so we can get more providers and agencies (especially centers – because of Title 20). Talk a bit of with department and more training with agencies. Looking forward to continued conversations about that and is interested into the details. Then Pathway to LRI as caretakers – talked to Director Green and staff, he requests that on the next agenda here, top issue priority at senator dinner and want to make sure that moves quickly. Last pieces, Low budget in the FSW – address that because that heart wrecking because of what the DHHS and PRO could do within the budget, then we had to say if we are going to serve more kids with fewer dollars or less kids with more money. That was rough, we thought \$10K was a reasonable spot to provide some supports to keep heads above water. Not sure he has heard discussion around how we are ensuring to use Medicaid dollars every single month. We did have to put in statute, but that is always changeable. \$46 million extra dollars that we could tap into this year for this.
- **Joe Valenti** Reserve comments until after the meeting. Did the committee vote on limited comments on the form? Staffing current survey says that Nebraska is the 7th highest payment for providers with 80% turnover rate. His view is that the providers have a problem with how the administer the funds.
- Kristen Larsen the chair has the ability to recognize anyone in the public at any time.
- **Jennifer Hansen** reading an email **Kim Banbridge**, parents across Nebraska are the backbone for children with IDD. I was my volunteer job coach this morning as independent provider was out of town. My sone comes home every weekend as I have no staff from

Friday to Monday, this has been going on for 9 years he has been living independent. .... Please consider paying.
