

Sahayak Takneek

Neeche di gayi seva ki paribhasha aur seemaen sabhi vivaran aur aavashyaktaon ko shamil nahi karti hain. Seva ke maapdand, seemaon, pradata ke prakar aur yogyata, aur pratipurti ki jaankari ke liye, sambandhit Medicaid HCBS DD Waiver ka sandarbh lein.

- A. Vyapak Vikasatmak Viklangta (CDD) Chhoot
- B. Vikasat Viklangata Vyakti Din (DDAD) Waiver
- C. Parivaarik Sahayata Waiver (FSW)

Seva Ki Paribhasha

Sahayak Takneek ek upkaran, yantra, ya vastu hai jo bhagidaar ki sakshamata ko badhane ke liye pratyek din ke jeevan ke gatividhiyon ko poora karne ya unke apne ya parivarik ghar mein apne vatavaran ko niyantrit karne ke liye istemal kiya jata hai. Sahayak Takneek ka upyog bhagidaar ki staff madad ki avashyakta ko kam kar sakta hai.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 - 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Sahayak Takneek mein shamil hai:
 - 1. Upkaran, yantra, ya vastu ki kharid ya kiraya par lena;
 - 2. Sahayak Takneek vastuon ka design karna, apnaana, sthapit karna, rakhrakhav karna, marammat karna, aur badalna;
 - 3. Sahayak Takneek yantron ke saath ISP mein avashyak chikitsa, hastakshep, ya anya sevaon ka samanvay aur upyog;
 - 4. Bhagidaar aur ghar ke anya sadasyon ke liye prashikshan; aur
 - 5. Bhagidaar ko unke ghar mein samarthan dene wale prayak ke liye prashikshan.
- C. Sahayak Takneek ke udaharan hain, lekin in tak simit nahi:
 - 1. Sanchar upkaran;
 - 2. Vishesh bistar; ya
 - 3. Swayamsth uthane wale yantra.
- D. Sahayak Takneek ki nimnlikhit seemaayein hain:
 - 1. Sampoorana Sahayak Takneek ko lagu rajya ya sthaniya nirman niyamon aur utpadan, design aur sthapna ke manako ke anusar pradan kiya jana chahiye.
 - 2. 500\$ se adhik moolya ki vastu mein insurance ya vistaarit warranty honi chahiye.
 - 3. Jo vastu beema se rakshit nahi hai aur jo nuksan, chori, ya kho gayi ho, use har do saal mein ek baar badla ja sakta hai.

4. DDD ko kisi uchit Medicaid-naamaankit peshewar pradata dwara vatavaran sambandhi chinta ka sthaniya moolyankan karwane ki avashyakta ho sakti hai. Moolyaankan Paryavaran Sudhaar Moolyaankan ke tahat pradan kiya jata hai.
5. Sahayak Takneek Medicaid ke madhyam se pradan ki ja rahi anya saman sevaon se milti-juliti, badalne wali, ya nakal nahi ho sakti. Ek bhagidaar ko is seva ka anurodh karne se pehle yah pata kar lena chahiye ki kya Medicaid, sahayak takneek ke liye bhugtan karega.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Waiver ka Sabhi seva pradataon ko yah karana hoga:
 1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Sahayak Takneek ek vikreta dwara pradan ki ja sakti hai.
 1. Ek vikreta ek company ya sanstha hai jo Medicaid pradata ke roop mein registered hai, lekin DD pradata ke roop mein pramanit nahi hai.
- C. Sahayak Takneek ko swayam-nirdeshit kiya ja sakta hai.
- D. Bhagidaar ka ek rishtedaar, lekin uska abhibhabak ya anya kanuni roop se zimmedar vyakti nahi, jab ve anya avashyaktaon ko pura karte hain, tab ve Sahayak Takneek pradan kar sakte hain. Kyonki yeh seva keval vikretaon se uplabdh hai, isliye rishtedaar ko vikreta ka karmachaari hona hoga.

Mullya

- A. Sahayak Takneek ko bhagidaar ke varshik vyaktigat budget ke antargat khareedi jani chahiye.
- B. Sahayak Takneek ko pratyek vastu ke liye pratipurti di jati hai.
- C. Sahayak Takneek ka varshik budget seema \$2,500 hai.
 1. Ek bhagidaar apatti janak swasthya ya suraksha ki avashyakta ke karan varshik budget seema se adhik vittiya sahayata ka anurodh kar sakta hai.
 2. DDD ki manzoori uplabdh vitran ke aadhar par nirnayit ki jati hai.
- D. Ek vitarak apne saman ko samanya janata se jyada nahi bech sakta. Ek vitarak jo kisi vishesh samuh, jaise ki students ya vridh nagrikon ko chhoot deta hai, usi chhoot ko us samuh ke ek bhagidar ko bhi dena chahiye.
- E. Sahayak Takneek ke liye mullya mein yatra ka kharch shamil nahi hai.
