Seva Ki Paribhasha

Vyavhaarik Ghar Par Kaushal Vikas ek chhoti avadhi ki kaushal vikas seva hai jo ek pratyabhagi ko pradan ki jaati hai jiska baar-baar ghambeer mansik swasthya stithi ya vyavhaar unhe apni niyमित dinacharya ki gatividhiyon ya rozgar mein bhag lene se rokta hai aur jo akela ghar mein nahi rah sakta.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Vyavhaarik Ghar Par Kaushal Vikas mein shaamil hai:
 1. Ek pratyabhagi ke liye samarthan seva jo:
 - a. Baar-baar hone wali mansik swasthya stithi ka anubhav karta ho; ya
 - b. Baar-baar ghambeer vyavhaarik sankat ka samna karta ho; aur
 2. Dainik Jeevan ki Gatividhiyon, Swasthya Rakshan, aur Nigraani mein Sahayata.
- C. Vyavhaarik Ghar Par Kaushal Vikas ek kaushal vikas seva hai aur ismein kaushal vikas karyakram shaamil hone chahiye. Vyakti vishesh kaushal vikas karyakram chalaye jaane chahiye, aur jab bhi seva pradan ki jaaye, tab har baar data record kiya jaana chahiye.
- D. Vyavhaarik Ghar Par Kaushal Vikas ke neeche diye gaye seemaayein hain:
 1. Vyavhaarik Ghar Par Kaushal Vikas sirf pratyabhagi ke ghar mein hi pradan kiya ja sakta hai.
 2. Pradata ko pratyabhagi ke saath uske niwas sthal par seva pradan karni chahiye.
 3. DDD clinical team ko is seva ke liye anurodhon ko seva ke manzoori se pehle manzoor karna hoga aur is seva ke upyog ki nirantar nigraani karni hogi.
 4. Ek pratyabhagi vyavhaarik ghar par kaushal vikas ko anya din sevaon ke saath milakar prapt kar sakta hai, lekin kul milaye gaye ghante hafte mein 35 ghante se adhik nahi ho sakte. Ek hafte ko is prakar paribhashit kiya jaata hai: 12:00 am Somvaar se lekar 11:59 pm Ravivaar tak. Anya din sevaayein hain:

- a. Vyask Din;
 - b. Samudaayik Samanvay;
 - c. Dinik Samarthan;
 - d. Chikitsa Ghar Par Kaushal Vikas;
 - e. Vavsayik prashikshan se pehle ka;
 - f. Chhoti Samuhik Vyavsayik Sahayata;
 - g. Samarhit Rojgar – Vyaktiगत;
 - h. Samarhit Rojgar – Anukaran Seva; aur
 - i. Vavsayik Punarvasan naukri ki talash aur naukri coaching.
5. Vyavhaarik Ghar Par Kaushal Vikas keval un pratyabhagiyon ko uplabdh hai jo Niwas Kaushal Vikas prapt kar rahe hain.
 6. Vyavhaarik Ghar Par Kaushal Vikas tab tak upyog nahi kiya ja sakta jab ek pratyabhagi Chikitsaatmak Niwas Kaushal Vikas, Svatantra Jeevan, ya Samarhit Parivarik Jeevan prapt kar raha ho.
 7. Yaatra ka kharch Vyavhaarik Ghar Par Kaushal Vikas ke mullya mein kharch shaamil nahi hai.
 8. Vyavhaarik Ghar Par Kaushal Vikas kisi bhi seva ya seva ke kisi hissa ko shaamil nahi kar sakta jo lok shiksha ke madhyam se uplabdh ho:
 - a. Pratibhagee ke sthaniya school jila mein chalu karyakram, jismein school ke baad ki dekhbhal aur aise dinon ki sevaayein shaamil hain jab school band ho, jaise ki garmiyon ki chhuttiyan, nirdharit school chhuttiyan, aur shikshak seva divas;
 - b. Pratibhagee ke liye sthaniya school jila dwara nirdharit school ke samay ke dauran, chahe school ka prakar kuch bhi ho (sarvajanik, private, ya ghar par); aur
 - c. Jo shikshan seva ke ghante pradan kiye jaate hain ya uplabdh hote hain, unhe kul milaye gaye din seva ke ghanton mein shaamil kiya jaata hai, jo ki hafte mein 35 ghante se adhik nahi ho sakte.
 9. Vyavhaarik Ghar Par Kaushal Vikas pratyabhagi ki avashyakta par adharit hai, jiska niyमित roop se moolyankan DDD clinical team dwara kiya jata hai.
 10. Vyavhaarik Ghar Par Kaushal Vikas Medicaid ke madhyam se pradan ki ja rahi anya saman sevaon ke saath na toh samanantar kar sakta hai, na unka badal sakta hai, aur na unhe nakal kar sakta hai.
- E. Vyavhaarik Ghar Par Kaushal Vikas pratyek ghatna ke liye 90 calendar din tak seemit hai. Pratyek ghatna ke liye atirikt ghanton ko DDD Kendriya Karyalaya prashasan dwaara manzoor kiya jaana chaahiye.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

- A. Waiver ka Sabhi seva pradaataon ko yah karana hoga:
 1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Vyavhaarik Ghar Par Kaushal Vikas DD sanstha pradata dwara pradan kiya ja sakta hai.
 1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlkhit ke liye zimmedar hai:

- a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki योग्यता, अनुभव, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye योग्य हो सकेin;
 - d. DHHS के liye prashikshan योजनायेin उपलब्ध कराने के liye सहमत होना;
 - e. सेवा की पर्याप्त उपलब्धता और गुणवत्ता सुनिश्चित करना; और
 - f. Anya prashasanik kriyaen.
- C. Vyavhaarik Ghar Par Kaushal Vikas svayan-nirdeshit nahi kiya ja sakta.
- D. Pratyabhagi ka ek rishtedaar, lekin pratyabhagi ka abhibhabak ya anya kanuni roop se jimmedar vyakti nahi, tab Vyavhaarik Ghar Par Kaushal Vikas pradan kar sakta hai jab ve anya avashyaktaon ko pura karte hain. Kyunki yeh seva sirf sanstha pradataon ke dwara उपलब्ध है, isliye rishtedaar ko sanstha pradata ka karmachari hona padega.
- E. Vyavhaarik Ghar Par Kaushal Vikas ek kaaryarat electronic visit verification (EVV) pranali ki avashyakta hoti hai jo seva के नियोजन की check-in और check-out को electronically sambhavit karti hai. Vyavhaarik Ghar Par Kaushal Vikas pradataon के liye EVV pranali के liye computer kaushalon aur takneek tak pahunch की avashyakta hoti hai.
