### Seva Ki Paribhasha

Baal Divas Kaushal Vikas ek aisi seva hai, jo 20 varsh ya usse kam umra ke bhagidaar ko unke jeevan ke anukool kaushalon ko sikhane, banaye rakhne, ya sudharne mein madad karti hai. Baal Divas Kaushal Vikas samudaay mein hota hai, bhagidaar ke vyaktigat parivaarik ghar se alag, jahan lakshya svatantrata aur vyaktitv vikas ko badhava dene ke liye samarthan pradan karna hai, saath hi samudaay mein milan ko protsahit karna hai.

### Pradan Karne Ki Shartein

- A. Baal Divas Kaushal Vikas mein shamil hain:
  - 1. Svantrata badhane ke liye kaushal vikas ki gatividhiyan;
  - 2. Samudaayik gatividhiyan jo samajik aur manoranjan kaushalon ko badhane ke liye hain;
  - 3. Samudaayik gatividhiyan jo samajik aur manoranjan kaushalon ko badhane ke liye hain; aur
  - 4. Aise nigrani aur niyantran jo vyakti ko bina viklangata ya vishesh swasthya avastha ke diye jaane wale niyantran se alag ho.
- B. Baal Divas Kaushal Vikas ek kaushal vikas seva hai aur ismein kaushal vikas karyakram shamil honi chahiye. Vyakti vishesh kaushal vikas karyakram chalayе jaane chahiye, aur jab bhi seva pradan ki jaaye, tab har baar data record kiya jaana chahiye.
- C. Baal Divas Kaushal Vikas ke udaharan hain, lekin in tak simit nahi hain:
  - 1. Ek bhagidaar ko doosron ke saath saanjha karna sikhana;
  - 2. Ek bhagidaar ko unki umra se sambandhit gatividhiyon mein bhaag lena sikhana, jaise khel, rang bharna, aur electronics; ya
  - 3. Ek bhagidaar ko juta bandhna, cot ki zipp lagana/utarna, aur haath aur chehra dhona sikhana.
- D. Baal Divas Kaushal Vikas ki nimnalikhit seemaayein hain:
  - 1. Yeh un bhagidaaron ke liye uplabdh hai jo 21 varsh se kam umra ke hain aur apne vyaktigat parivaarik ghar mein rahte hain.
  - 2. Baal Divas Kaushal Vikas bhagidaar ke parivaar ke kisi abhibhaavak ya kanuni roop se zimmedar sadasya dwara pradaan nahi kiya ja sakta.
  - 3. Baal Divas Kaushal Vikas mein koi bhi seva ya seva ka hissa shamil nahi ho sakta jo sarvajanik shiksha ke madhyam se uplabdh hai, jisme shamil hain:

- a. Pratibhagee ke sthaniya school jila mein chalu karyakram, jismein school ke baad ki dekhbhal aur aise dinon ki sevaayein shaamil hain jab school band ho, jaise ki garmiyon ki chhuttiyan, nirdharit school chhuttiyan, aur shikshak seva divas;
  - b. Pratibhagee ke liye sthaniya school jila dwara nirdharit school ke samay ke dauran, chahe school ka prakar kuch bhi ho (sarvajanik, private, ya ghar par); aur
  - c. Jo shikshan seva ke ghante pradan kiye jaate hain ya uplabdh hote hain, unhe kul milaye gaye din seva ke ghanon mein shaamil kiya jaata hai, jo ki hafte mein 35 ghante se adhik nahi ho sakte.
4. Jo bhagidaar Aawasik Kaushal Vikas ya Chikitsik Aawasik Kaushal Vikas prapt kar rahe hain, ve Baal Divas Kaushal Vikas nahi le sakte.
  5. Jo bhagidaar Baal Divas Kaushal Vikas prapt kar rahe hain, ve Samudaayik Ekikaran nahi le sakte.
  6. Yeh sewa Medicaid ke madhyam se pradan ki gayi anya saman sewaon ke saath mil nahi sakti, unhe badal nahi kar sakti, aur na hi unka nakal kar sakti hai.
  7. Baal Divas Kaushal Vikas ke liye Sampoorana DD Waiver par bhagidaaron ke liye saptaahik seema 70 ghante hai. FSW par bhagidaaron ke liye koi saptaahik seema nahi hai. Ek hafte ko is prakar paribhashit kiya jaata hai: 12:00 am Somvaar se lekar 11:59 pm Ravivaar tak.

## Pradata Ki Avashyaktaayein

*Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradaton ke baare mein samanya jankari dene ke liye hai.*

- A. Waiver ka Sabhi seva pradaton ko yah karana hoga:
  1. Medicaid pradata hona chahiye;
  2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
  3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
  4. Anurodh par DHHS prashikshan poora karna chahiye; aur
  5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Baal Divas Kaushal Vikas ek DD sanstha pradata ya svatantra pradata dwara pradan kiya ja sakta hai.
  1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlikhit ke liye zimmedar hai:
    - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
    - b. Karmachariyon ko unki yogyata, anubhav, aur pradarshit kshamataon ke aadhar par niyukt karna;
    - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye yogy ho sakein;
    - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
    - e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
    - f. Anya prashasanik kriyaen.
  2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata ke roop mein registered hai aur ek bhagidaar dwara niyukt kiya gaya hai. Bhagidaar apne pradata ko niyukt karne aur nigrani rakhne ke liye zimmedar hota hai.
- C. Baal Divas Kaushal Vikas ko swayam-nirdeshit kiya ja sakta hai.
- D. Bhaagidaar ka koi rishtedaar, lekin abhibhaavak ya bhagidaar ka koi aur kanuni roop se zimmedar vyakti, Baal Divas Kaushal Vikas pradan kar sakta hai jab ve anya avashyaktaon ko pura karte hain.

## Mullya

- A. Baal Divas Kaushal Vikas ko bhagidaar ke varshik vyaktigat budget ke andar kharida jaana chahiye.
- B. Baal Divas Kaushal Vikas mein bhagidaar ki viklangata se sambandhit na hone wale bachon ki dekhbhaal ka mool kharcha shamil nahi hai.
  - 1. Bachon ki dekhbhaal ka mool kharcha woh mulya hai jo ek dekhbhaal kendr ya vyakti pradata dwara un bachon se liya jata hai jinke paas viklangata ya vishesh swasthya avastha nahi hoti.
  - 2. Bachon ki dekhbhaal ka mool kharcha ya niyमित dekhbhaal ka kharcha mata-pita ya abhibhaavak ki zimmedari hoti hai.
  - 3. Baal Divas Kaushal Vikas, bachon ki viklangata ya vishesh swasthya avastha se sambandhit unki vishesh avashyaktaon ke karan, niyमित dekhbhaal ke upar aur usse zyada ka kharcha pradan karta hai.
- C. Yatra ka kharcha hai:
  - 1. Baal Divas Kaushal Vikas ke dauran mulya mein shamil hai;
  - 2. Baal Divas Kaushal Vikas jahan se shuru hota hai, us sthal ke liye mulya mein shamil nahi hai, kyunki yeh mata-pita ya abhibhaavak ki zimmedari hoti hai; aur
  - 3. Baal Divas Kaushal Vikas jahan khatam hota hai, us sthal ke liye mulya mein shamil nahi hai, kyunki yeh mata-pita ya abhibhaavak ki zimmedari hoti hai.
