Samudaayik Samavesh – Sanstha ya Svatantra 9845

Seva Ki Paribhasha

Samudaayik Samavesh ek kaushal vikas sewa hai, jo svayam sahayata, vyavhaar, samajikikaran, aur anukoolan kaushalon ki shiksha pradan karti hai. Samudaayik Samavesh samudaay mein ek gair-avasik vatavaran mein hota hai.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Samudaayik Samavesh mein shamil hai:
 1. Kaushal vikas ki gatividhiyan jo svatantrata aur vyakti ke vyaktigat chunoav ko badhane ke liye banayi gayi hain;
 2. Samudaayik sadasyon ke saath jodne aur anukool samvaad karne ke avsar; aur
 3. Dainik Jeevan ki Gatividhiyon, Swasthya Rakshan, aur Nigraani mein Sahayata.
- C. Samudaayik Samavesh ek kaushal vikas sewa hai aur ismein kaushal vikas karyakram shamil honi chahiye. Vyakti vishesh kaushal vikas karyakram chalaye jaane chahiye, aur jab bhi seva pradan ki jaaye, tab har baar data record kiya jaana chahiye.
- D. Samudaayik Samavesh ke udaharan hain, lekin in tak simit nahi hain:
 1. Ek bhagidaar ko samudaayik samuha, church samuha, pustak club, patte ka club, ya machhli pakadne ke club mein shamil hona aur bhag lena sikhana;
 2. Ek bhagidaar ko shopping par jana, sangit samaaroh mein shamil hona, bahar khana khane jana, ya khel pratiyogita mein bhag lena sikhana;
 3. Ek bhagidaar ko sva-arthik karyon mein shamil hona aur bhag lena sikhana, jaise ki ek pashu ashram ya Bhojan Seva karyakram mein.
 4. Ek bhagidaar ko samudaay mein safar karna sikhana, jaise ki sarvajanik parivahan ka upyog karna ya bike chalana.

- E. Is seva ka ek hissa virtual roop se diya ja sakta hai, jo ki is tak simit nahi hai, balki shamil hai:
1. Pratyabhagi ki zarurat ko shabdik sanket aur anya sahayata ke madhyam se poora kiya ja sakta hai, jo virtual roop se pradan ki ja sakti hai;
 2. Yeh moolik aur madhyam stariya funding ke antaragat pratyabhagiyon ke liye uplabdh hai;
 3. Har hafte mein diye gaye samudaayik samavesh ka adhikansh hissa vyakti roop se diya jana chahiye;
 4. Online sahayata ke liye kul milaye gaye ghante hafte mein 10 ghante se adhik nahi ho sakte; aur
 5. Yeh 10 ghante din sevaon ke 35 ghante per hafte ki seema mein shamil hain.
- F. Samudaayik Samavesh ki nimnalikhit simaayein hain:
1. Samudaayik Samavesh ke dauran, ek bhagidaar aise kaam nahi kar sakta jiske liye doosre logon ko maasik ya bina maasik bhugtan milta ho, lekin wo seva karyon aur shaukon mein bhag le sakta hai, jisme kam paisa milta hai.
 2. Samudaayik Samavesh ke dauran, ek pradata aise gair-samaveshit gatividhiyon ke liye bil nahi bana sakta, jaise ki van se safar karna ya khaali park mein jana, jab samudaayik sadasyon ke saath mel-jol ka avsar kam ho ya bilkul na ho.
 3. Ek hafte mein Samudaayik Samavesh ke liye jo samay bil kiya jata hai, uska adhikansh hissa samudaay mein bitaya jana chahiye.
 4. Ek bhagidaar Samudaayik Samavesh ko anya din sewaon ke saath prapt kar sakta hai, lekin kul sanyukt ghante 35 ghante pratidin se adhik nahi ho sakte. Ek hafte ko is prakar paribhashit kiya jaata hai: 12:00 am Somvaar se lekar 11:59 pm Ravivaar tak. Anya din sevaayein hain:
 - a. Vyask Din;
 - b. Vavhaarika Ghar Par Kaushal Vikas;
 - c. Dinik Samarthan;
 - d. Chikitsa Ghar Par Kaushal Vikas;
 - e. Vavsayik prashikshan se pehle ka;
 - f. Chhoti Samuhik Vyavsayik Sahayata;
 - g. Samarthat Rojgar – Vyaktiagat;
 - h. Samarthat Rojgar – Anukaran Seva; aur
 - i. Vavsayik Punarvasan naukri ki talash aur naukri coaching.
 5. Samudaayik Samavesh mein koi bhi sewa ya seva ka hissa shamil nahi ho sakta jo sarvajanik shiksha ke madhyam se uplabdh ho, jisme shamil hain:
 - a. Pratibhagee ke sthaniya school jila mein chalu karyakram, jismein school ke baad ki dekhbhal aur aise dinon ki sevaayein shaamil hain jab school band ho, jaise ki garmiyon ki chhuttiyan, nirdharit school chhuttiyan, aur shikshak seva divas;
 - b. Pratibhagee ke liye sthaniya school jila dwara nirdharit school ke samay ke dauran, chahe school ka prakar kuch bhi ho (sarvajanik, private, ya ghar par); aur
 - c. Jo shikshan seva ke ghante pradan kiye jaate hain ya uplabdh hote hain, unhe kul milaye gaye din seva ke ghanton mein shaamil kiya jaata hai, jo ki hafte mein 35 ghante se adhik nahi ho sakte.
 6. Samudaayik Samavesh prapt karne wale bhagidaar Bal Divas Kaushal Vikas nahi le sakte.
 7. Yeh sewa Medicaid ke madhyam se pradan ki gayi anya saman sewaon ke saath mil nahi sakti, unhe badal nahi kar sakti, aur na hi unka nakal kar sakti hai.
- G. Samudaayik Samavesh aspatal ke paristhiti mein pradan kiya ja sakta hai jab ek bhagidaar ko gambhir chikitsa ke liye bharti kiya jata hai.

1. Sahayata pratyabhagi ki avashyaktaon ko hospital ke paripeksh mein poora karne aur unke ghar wapas jane ke liye ek sahad parivartan mein madad karne ke liye design ki gayi hai.
2. Sahayata mein un kaushalon ka shikshan shamil hai jo pratyabhagi ko unke vartaman swatantrata ke star ko banaye rakhne mein madad karenge, avashyakta anusar vyavhaaric sahayata pradan karna, aur dincharya ke karyo mein sahayata jo pratyabhagi ko unke upchar aur arogya mein hospital mein madad karte hain.
3. Sahayata mein koi bhi swasthya rakshan kriyaen, upchar, prakriyaen, davaon ka prabandhan, ya abhyas shamil nahi hain, jo hospital ke karmachariyon dwara kiye jane chahiye.
4. Vyakti kendrit seva yojna ko tab update kiya jayega jab yeh seva hospital ke paripeksh mein pradan ki jaye aur jab pratyabhagi hospital chhode.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari देने के लिये है।

- A. Waiver ka Sabhi seva pradataon ko yah karana hoga:
 1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
 3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. Samudaayik Samavesh ek DD sanstha pradata ya swatantra pradata ke dwara pradan kiya ja sakta hai.
 1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlkhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo pratibhagee ke saath kaam karte hain;
 - b. Karmachariyon ko unki योग्यता, अनुभव, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal देने के लिये योग्य हो सकें;
 - d. DHHS के लिये prashikshan yojnaayein uplabdh karane के लिये सहमत hona;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
 - f. Anya prashasanik kriyaen.
 2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata के roop mein registered hai aur ek bhagidaar dwara niyukt kiya gaya hai.
 - a. Bhagidaar apne pradata ko niyukt karne aur nigrani rakhne के लिये zimmedar hota hai.
- C. Samudaayik Samavesh swayam-nirdeshit ho sakta hai.
- D. Ek bhagidaar ka rishtedaar, lekin unka abhibhabak ya anya kanuni roop se zimmedar vyakti nahi, Samudaayik Samavesh pradan kar sakta hai jabki ve anya aavashyaktaon ko poora karte hain.

- A. Samudaayik Samavesh ko ek bhagidaar के varshik vyaktigat budget rashi के antaragat hi kharida jana chahiye.
- B. Samudaayik Samavesh ko pratidin ki mullya par puri kiya jata hai.

C. Yatra ka kharcha hai:

1. Samudaayik Samavesh ke dauran mullya mein shamil hai;
2. Jahaan se Samudaayik Samavesh ki shuruat hoti hai, us sthal tak ki mullya mein shamil nahi hai; aur
3. Jahaan Samudaayik Samavesh samapt hota hai, us sthal se ki mullya mein shamil nahi hai.
