### Seva Ki Paribhasha

Saathi ek seva hai jo HCBS Waiver ke tahat vruddh aur viklang (AD) ya Samarthit Mastisk Ghatna (TBI) Waiver ke liye vyaskon ke liye pradan ki jaati hai. Yeh seva 18 saal aur usse adhik umr ke bhagidaron ko unke gharo mein aur kabhi-kabhi anya samudaayik sthal par nigrani aur/ya samajik sahayata pradan karti hai. Yeh seva bhagidaar ki moolyaankan ki gayi avashyaktaon ke anusar nigrani, halka safai ka kaam, bill bharna, kaam sewa, avashyak shopping, khana banana, aur kapde dhone ki seva shamil kar sakti hai.

### Pradan Karne Ki Shartain

- A. Saathi ki avashyakta ko bhagidaar ke moolyaankan ke dauran pehchana jaana chahiye aur ise vyakti-kendrit yojana (PCP) mein shamil kiya jaana chahiye.
- B. Pradata ek samay mein ek se adhik bhaagidar ko seva nahi de sakte, jab tak bhaagidar ki PCP mein anya roop se na likha ho.
- C. Saathi bhagidaron ko unka kaam pura karne mein madad karta hai, jo ve apne aap karte agar unhein koi viklangta nahi hoti.
- D. Seva ko ek samayik ya nirantar roop se pradan kiya ja sakti hai.
- E. Saathi bhagidaar ko is tareeke se pradan kiya jaayega jisse unki svatantrata aur gopniyata jitna ho sake utna bana rahe.
- F. Saathi ko nimnlikhit mein se ek ya adhik kaamon mein madad ke liye manzoor kiya ja sakti hai:
  1. Bill Bharna: Vittiya vyavastha ko sangathit karna aur avashyakta par bill bharna.
  2. Kaam Sewa: Jab bhagidaar aam taur par saath na ho, to rakhwali seva se sambandhit avashyaktaon ke liye seva.
    - a. Jab bhagidaar pradata ke saath jaate hain, to pradata ko yatra ke liye alag se koi rashni nahi lena chahiye.
  3. Avashyak Kharidari: Khana, kapda, aawas, ya vyaktigat dekhbhal ke saman prapt karna.
  4. Khana Banana: Aise bhojan banana jo svatantrata banaye rakhne ke liye avashyak ho.
    - a. Bhagidaar avashyak bhojan banane ke saman pradan karte hain.
  5. Kapde Dhona Ki Seva: Bhagidaar ke ghar mein kapde dhona, sukhana, press karna, murjhaana, aur rakna, ya bhagidaar ki taraf se kapda dhona ke kendron ki seva ka upyog karna.
    - a. Bhagidaar ko sabun aur machine ka upyog karne ki fees pradan karni hoti hai.
  6. Halka Ghar Ka Kaam: Jhaadna, mez ka pocha lagana, jhadu dena aur pochha lagana, kachra bahar nikalna, aur vacuum karna.
    - a. Samanya ghar ke kaam un tak simit hote hain jo bhagidaar ke ghar ko banaye rakhne aur chalane ke liye avashyak hote hain jab ve akela ghar ke liye zimmedar hote hain.
  7. Nigrani: Bhagidaar ke saath din ke ek hissa mein sampark mein rehna jab bhagidaar akela hota. Nigrani ke dauran bhagidaar ko akela nahi chhoda ja sakti.

- a. Nigrani ki avashyakta ko PCP mein spasht roop se darj kiya jana chahiye aur ismein shamil ho saktा hai, lekin yah tak simit nahi hai:
  - i. Sanket aur yaad dilana;
  - ii. Aise gair-chikitsa kriyaen jo bhagidaar ki suraksha aur aaram ke liye avashyak ho; aur
  - iii. Ghar mein upasthit rehna aur manobhansh ya anya smriti mein kami ke karan bhagidaar ko asurakshit tareke se bahar nikalne se bachana, ya yah sunishchit karna ki bhagidaar khana khate waqt apna gala na atakaye.
- G. Saathi mein haath se nursing dekhbhāl shamil nahi hoti. Jab ADL ya swasthya sambandhi kaam mein madad ki avashyakta ho, to vyaktigat dekhbhāl ko Saathi ke bajaye manzoor kiya jana chahiye.
- H. Yeh seva Vyaktigat Dekhbhāl ya Chore ke niyamit pradanon ko nakal nahi kar sakti, jab yeh ek sath manzoor kiye jaate hain.
- I. Saathee mein kaushal vikas nahi shamil hai aur yeh pratibhaagi ko apne swarath, samajikaran, ya anukoolan kaushalon ko prapt karne, banaye rakhne, ya sudharne mein madad nahi karta.
- J. Saathi mein dincharya ki gatividhion mein sahaayata; bhaari ghar ke kaam; ghar ke upkaran, upkaran ya furniture ki dekhbhāl; chhoti marammat; bagwani; keetnashak sewa; ya naaliyon se paani ki safai shaamil nahi hai.
- K. Saathi mein kisi aur ke liye koi kaam shaamil nahi hai, siwaye pratibhaagi ke.
- L. Bhaagidaron ko nirantar roop se pratyek vyakti pradataon par nazar rakhna aur unka nigrani karna zimedari hoti hai.
- M. Kam se kam mahine mein ek baar Seva Samanvayak aur bhagidaar bhagidaaro ki PCP ka nigrani karenge. Isme waiver sevaon ke upyog ya anuupyog ka nigrani karna shamil hai.
- N. Ek bhagidaar ko is seva ko un samayon mein pradan karne ki anumati nahi di ja sakti, jab yeh Vishram, Vayask Din Swasthya, Vyaktigat Dekhbhaal, Swatantrata Kaushal Vikas, ya Gair-Chikitsaki Yatayat sevaon ke samay ke saath milte hain.
- O. AD aur TBI Waivers ke antaragat sevaen sirf un atirikt sevaon tak seemit hoti hain jo Medicaid rajya yojna ke tahat anya roop se shamil nahi hoti hain, lekin sansthaagat karan ko talne ke waiver ke lakshyon ke anukul hoti hain.

## Pradata Ki Avashyaktaayein

- A. Waiver ka Sabhi seva pradaataon ko yah karana hogा:
  - 1. Medicaid pradata hona chahiye;
  - 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
  - 3. Medicaid aur lambe samay Dekhbhaal Seva Pradata Samjhauta mein varnit maapdandhon ka paalan karna;
  - 4. Anurodh par DHHS prashikshan poora karna chahiye; aur
  - 5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.
- B. TBI Waiver pradataon ko Grihasth seva pradan karne se pehle DHHS dwara manzoor TBI prashikshan poora karna anivarya hai.
- C. Saathee seva ko ek kaaryarat electronic yatra satyaapan (EVV) pranali ki avashyakta hoti hai, jo seva ke niyojan ke samay ko electronic roop se check-in aur check-out mein madad karti hai.
- D. Companion pradataon ke liye EVV pranali ke liye computer kaushal aur takneek tak pahunch anivarya hai.
- E. Saathee pradataon ko pratyek bhaagidaar ki chikitsa aur vyaktigat avashyaktaon ki paryapt jaankari prapt karni chahiye aur sabhi parivartanon ko Seva Samanvayak ko suchit aur report karna chahiye.
- F. Ek pradata vyakti ya sanstha dono ho saktा hai.
- G. Har sanstha pradata ko yeh sab karna hogा:
  - 1. Apne karmchariyan ko unki yogita, anubhav, aur pradarshit kshamtaon ke aadhaar par niyukt karna;
  - 2. Karmchariyan ko prashikshan pradan karna taaki ve avashyak dekhbhāl ke star ko pradan karne ke liye yogya ho sakein;

3. Prashikshan yojnaayein DHHS ke liye uplabdh karane par sahmat hona; aur
4. Sevaon ki paryapt uplabdhata aur gunvatta ko sunishchit karen.

## Mullya

- A. Darakhton ko ek vyakti pradan karta ke adhar par, pradan karta aur Sansadhan Vikasak (RD) ke beech ek samjhota prakriya ke madhyam se sthapit kiya jata hai.
- B. Darakhton ko pratyek varsh, pradan karta ke varshik samjhote ke samapan ke samay par punaravalokan kiya jata hai.
- C. Pradan karta tab punah samjhota karne ki maang kar sakte hain jab kisi bhagidaar ki dekhbaal ki avashyaktaen badh jati hain.
- D. Darakht ke samjhote mein bhagidaar ki seva ki avashyaktaon ka star, pradan karta ki kushalta ka star, aur bhaugolik sthal ko dhyan mein rakha jata hai.
- E. Mullya ka nirdharan samanya aur prachalit mullya ke aadhar par kiya jata hai, jo pradan karta dwara ek niji bhugtaan karne wale vyakti se liye jane wale dar se zyada nahi hote.
- F. Seva ki avriti ghantawaar, dainik ya ghatnaon ke adhar par hoti hai.
