Seva Ki Paribhasha

Paramarshatmak Mulyankan ko vyavhaarika samarthan viksit aur lagu karne ke liye pradan kiya jata hai, jo ek bhagidaar ko unki vartaman sevaayein banaaye rakhne mein madad karta hai, saath hi unki aur doosron ki suraksha sunishchit karta hai. Paramarshatmak Mulyankan pratyabhagi ki svatantrata aur unke samudaay mein bhagidari ko badhata hai.

Pradan Karne Ki Shartein

- A. Ek pratyabhagi apni zarurat ke adhar par har seva ka chayan karta hai.
 - 1. Sevayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - 2. Chuni gayi waiver sevaen aur inhe pradan karne wala vyakti pratyabhagi ke Vyaktigat Sahayak Yojana (ISP) mein darj kiya jata hai.
- B. Paramarshatmak Mulyankan mein shamil hai:
 - 1. Ek pratyabhagi ko unke rehne aur seva prapt karne ke sthal par ya Telehealth ke madhyam se dekhna;
 - 2. Telehealth ke madhyam se ek vyavhaarika mulyankan poora karna;
 - a. Ek vyavhaarika mulyankan vishesh samasya vyavhaar ko pehchanta hai, us vyavhaar ka uddeshya ya kriya, ek sakaratmak badlaav vyavhaar ki pehchaan karta hai, aur samasya vyavhaar ko door karne ke liye sujhav deta hai.
 - b. Vyavhaarika mulyankan ko sakaratmak vyavhaar samarthan yojana viksit karne ke liye istemal kiya jata hai, jo sakaratmak badlaav vyavhaar sikhata hai aur samasya vyavhaar ko kam karta hai.
 - 3. Sakaratmak vyavhaar samarthan yojana, suraksha yojana, aur anya samarthan viksit karna;
 - 4. Vyavhaar samarthan yojana, suraksha yojana, aur anya samarthan par prashikshan pradan karna;
 - 5. Pratyabhagi ke ISP team ko sujhav dena; aur
 - 6. Vyavhaar samarthan yojana, suraksha yojana, aur anya samarthan ko avashyakta anusar lagu karna, moolyaankan karna, aur sudhaar karna.
- C. Paramarshatmak Mulyankan ek yogyaata vikas seva nahi hai, lekin yeh yogyaata vikas ke samarthan ke vikas mein madad karta hai.

D. Paramarshatmak Mulyankan ki nimnlkhit seemaayein hain:

1. Paramarshatmak Mulyankan Medicaid ke madhyam se pradan ki ja rahi anya saman sevaon se samanantar nahi ho sakta, unhe badal nahi sakta, ya unka nakal nahi kar sakta.
2. Prarambhik aur Avritti Parikshan, Nidan, aur Upchaar (EPSDT) - yeh ek Medicaid program hai jo 21 saal se kam umra ke bachon aur yuvaon ke liye parikshan, nidan aur upchaar ki sevaayein pradan karta hai.

Pradata Ki Avashyaktaayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktaayein shaamil nahi hain. Yeh is vishesh DD seva ke pradataon ke baare mein samanya jankari dene ke liye hai.

A. Waiver ka Sabhi seva pradaataon ko yah karana hoga:

1. Medicaid pradata hona chahiye;
2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karni chahiye;
3. Medicaid aur Dirgha kaalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
4. Anurodh par DHHS prashikshan poora karna chahiye; aur
5. Sarvabhaumik saavdhaniyon ka palan karna chahiye.

B. Paramarshatmak Mulyankan DD agency pradata, swatantra pradata, ya ek vikreta dwara pradan kiya ja sakta hai.

1. Ek DD sanstha pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnlkhit ke liye zimmedar hai:
 - a. Pratyabhagi ke saath kaam karne wale karmachariyon ya thekedaaron ko niyukt ya contract karna aur unki nigrani karna;
 - b. Karmachariyon ko unki योग्यता, अनुभव, aur pradarshit kshamataon ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve aavashyak star ki dekhbhal dene ke liye योग्य हो सकें;
 - d. DHHS के liye prashikshan yojnaayein uplabdh karane के liye सहमत होना;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunisshit karna; aur
 - f. Anya prashasanik kriyaen.
2. Ek DD swatantra pradata ek vyakti ya vikreta hai jo Medicaid pradata के roop में registered hai aur ek bhagidaar dwara niyukt kiya gaya hai.
 - a. Bhagidaar apne pradata ko niyukt karne aur nigrani rakhne के liye zimmedar होता है.
3. Ek vikreta ek company ya sanstha hai jo Medicaid pradata के roop में registered hai, लेकिन DD pradata के roop में प्रामाणित नहीं है.

C. Paramarshatmak Mulyankan swayan-nirdeshit ho sakta hai.

D. Pratyabhagi ka koi rishtedaar, लेकिन प्रत्येक व्यक्ति का अभिभावक या अन्य कानूनी रूप से जिम्मेदार व्यक्ति नहीं, जब वे अन्य अवश्याताओं को पूरा करते हैं, तब Paramarshatmak Mulyankan pradan kar sakte hain.

E. Paramarshatmak Mulyankan, jisme vyavhaarika mulyankan bhi शामिल है, ek dwara pradan kiya jana chahiye:

1. Licensed Swatantra Mansik Swasthya Chikitsak (LIMHP);
2. Licenced Manovigyanik; ya

3. Board-Pramanit Vyavhaar Vishleshak (BCBA), jise 1 September, 2024 se pehle licenced hona avashyak hai. Ek BCBA ko us tareekh se 90 din ke andar apna license prapt karna hoga. Ek baar license prapt kar lene par, ek BCBA ko Paramarshatmak Mulyankan poora karne ke liye LIMHP ya licenced manovigyanik ki nigrani ki avashyakta nahi hogi.
- F. Pradata ya vikreta ko har saal kam se kam do ISP team meetings mein bhaag lena hoga, jo vyakti roop se, phone ke dwara, ya Telehealth ke madhyam se ho sakti hain. Pradata team meetings mein bhaag lene ke liye samay ka billing nahi kar sakta.
