Seva Ki Paribhasha

Rozgar Khoj ek samay-seema mein prastut ki jane wali seva hai jo bhagidar ko yah soochit nirnay lene mein madad karti hai ki kya ve vyaktigat roop se ekikrit rozgar chahate hai ya swayam-rojgar. Khoj prakriya mein bhagidar ki ruchi, kaushalon, aur pasand ko dhyan mein rakha jata hai taki seva aur unke samanya lakshyon ke sath samanjas bana sake.

Pradan Karne Ki Shartein

- A. Ek bhagidar apni zarurat ke adhar par har seva ka chayan karta hai.
 - 1. Sevaayein swatantrata aur samudaayik ekikaran ko badhava deni chahiye; aur
 - 2. Bhagidar ki vyakti-kendrith yojna (PCP) mein chuni gayi chhoot sevaayein aur unhein pradan karne wale vyaktiyon ka ullekh hota hai.
- B. Rozgar Khoj mein yah sab shamil ho sakta hai, lekin sirf inhi tak seemit nahi hai:
 - 1. Bhagidar ke vishesh ruchi aur savaitanik kam ke liye unke kaushalon ki pehchan ke liye career anveshan kriyayein;
 - 2. Staniya kshetra mein vyaktigat roop se ekikrit rozgar ya swayam-rojgar ke avsar ki khoj;
 - 3. Yadi lagu ho, to bhagidar, unke abhibhavak ya conservator, ya shamil parivarik sadasyon ki chintaon ko door karne ke liye shiksha;
 - 4. Vyaparik tour, jankari mulakatein, aur/ya kary sthalon ka avlokan (job shadowing).
- C. Jab is seva ka kuch bhag virtual roop se diya jaye, to nimnalikhit shartein lagu hongin:
 - 1. Online sahayata (virtual supports) ke kul milaye gaye ghante hafte mein 10 ghante se adhik nahi ho sakte; aur
 - 2. Bhagidar ki avashyaktayon ko shabdik sanket aur anya sahayata ke madhyam se poora kiya ja sakta hai, jo virtual roop se pradan ki ja sakti hai;
- D. Rozgar Khoz ki nimnalikhit seemaayein hain:

1. Rozgar Khoj ki seema 40 ghante prati varsh hai, jiske beech seva ki punah-anumati ke liye kam se kam 365 din ka antarl hona chahiye, aur seva ko shuruat tithi se 30 calendar din ke andar samapt karna anivarya hai.
2. Rozgar Khoj anya diwas sevaaon ke sath milakar istemal kiya ja sakta hai, lekin kul yog ghante 1820 prati varsh se adhik nahi hone chahiye.
3. Rozgar Khoj mein bhag lena Sahayit Rozgar – Vyaktiagat ya Sahayit Rozgar – Anukaran ke liye avashyak nahi hai.

Pradata Ki Avashyaktayein

Nichee di gayi jankari mein sabhi pradata ki avashyaktayein shaamil nahi hain. Yeh is vishesh DD seva ke pradaton ke baare mein samanya jankari dene ke liye hai.

- A. Sabhi Chhoot Seva pradaton ko:
 1. Medicaid pradata hona chahiye;
 2. Nebraska Prashasanik Code ke sabhi lagu Titles aur Nebraska Rajya Vidhi ki paalan karna chahiye;
 3. Medicaid aur Dirgha kalin Dekhbhal Seva Pradata Samjhauta mein varnit manako ka palan karna chahiye;
 4. Department of Health and Human Services (DHHS) dwara mangi gayi training ko poora karna hoga; aur
 5. Sarvabhaumik savdhaniyon ka palan karna chahiye.
- B. Rozgar Khoj agency pradaton dwara di ja sakti hai.
 1. Ek agency pradata ek company hai jo Medicaid pradata ke roop mein panjikrit hai aur DHHS dwara DD sevaayein pradan karne ke liye pramanit hai aur nimnikhit ke liye zimmedar hai:
 - a. Un karmachariyon ki bharti aur nigraani jo bhagidar ke saath kaam karte hain;
 - b. Karmachariyon ko unki योग्यता, अनुभव, aur pradarshit kshamaton ke aadhar par niyukt karna;
 - c. Karmachariyon ko prashikshan pradan karna taaki ve avashyak star ki dekhbhal dene ke liye योग्य हो सकें;
 - d. DHHS ke liye prashikshan yojnaayein uplabdh karane ke liye sahamat hona;
 - e. Seva ki paryapt uplabdhata aur gunwatta sunischit karna; aur
 - f. Anya prashasanik kriyaen.
- C. Rozgar Khoz sva-nirdeshit nahi ho sakta hai.
- D. Rozgar Khoz ek parivarjan dwara prastut kiya ja sakta hai, lekin Kanooni Abhibhavak ya Kanooni Roop se Uttardayi Vyakti (LRI) dwara nahi. Kyunki yeh seva sirf sanstha pradaton ke dwara uplabdh hai, isliye rishtedaar ko sanstha pradata ka karmachari hona padega.

 2. Jahan Rozgar Khoz shuru hoti hai, us sthal tak ke shulk mein shamil nahi hai; aur
 3. Jahan Rozgar Khoz samapt hoti hai, us sthal se sambandhit shulk mein shamil nahi hai.
